

A meeting of the State Lands Commission was held in the office of the Director of Finance, Room 306 State Capitol, Sacramento, September 16, 1941, at 10:45 A. M.

The following bids were opened by the Commission:

1. Bid of George A. Applegarth on chrome ore and chrome concentrates on the N $\frac{1}{2}$  of NE $\frac{1}{4}$  of Section 16, T. 25 N., R. 7 W., M. D. M. Mr. Applegarth's bid was 12 $\frac{1}{2}$ % of the value of the chrome ore and chrome concentrates at the mine, and bid was made in duplicate and accompanied by a certified check, payable to the Treasurer of the State of California, in the amount of \$200.00.
2. Bid of Lawrence B. Wright on chrome ore and chrome concentrates on the SW $\frac{1}{4}$  of NE $\frac{1}{4}$  and NW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 16, T. 25 N., R. 7 W., M. D. M. Bid was 12 $\frac{1}{2}$ % of the value of the chrome ore and chrome concentrates at the mine, and was accompanied by a certified check payable to the Treasurer of the State of California, in the amount of \$200.00.
3. Bid of Samuel H. Dolbear on chrome ore and chrome concentrates on the S $\frac{1}{2}$  of SE $\frac{1}{4}$  of Section 16, T. 25 N., R. 7 W., M. D. M. Mr. Dolbear's bid was 12 $\frac{1}{2}$ % of the value of the chrome ore and chrome concentrates at the mine, and was accompanied by a certified check, payable to the Treasurer of the State of California, in the amount of \$200.00.
4. Bid of Frank Y. McLaughlin on chrome ore and chrome concentrates on the SE $\frac{1}{4}$  of NE $\frac{1}{4}$  and NE $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 16, T. 25 N., R. 7 W., M. D. M. Bid was 12 $\frac{1}{2}$ % of the value of the chrome ore and chrome concentrates at the mine, and was accompanied by a certified check, payable to the Treasurer of the State of California, in the amount of \$200.00.
5. Bid of Jettie T. Gray on chromite on the SE $\frac{1}{4}$  of NE $\frac{1}{4}$  and NW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 16, T. 25 N., R. 7 W., M. D. M. Mr. Gray bid royalty of 15 $\frac{1}{2}$ % upon the value of the minerals. Bid was accompanied by a cashier's check, payable to the Treasurer of the State of California, in the amount of \$200.00.
6. Bid of John H. Gray on chromite on the W $\frac{1}{2}$  of NE $\frac{1}{4}$  of Section 16, T. 25 N., R. 7 W., M. D. M. This bid was for 15 $\frac{1}{2}$ %, and was accompanied by a cashier's check, payable to the Treasurer of the State of California, in the amount of \$200.00.

Upon a statement by the Chairman that the procedure followed in the past on all of these bids has been to ask the State Mineralogist to study them and give his opinion before any action is taken, the Commission directed Mr. A. P. Ireland to take the necessary steps to confer with Mr. Bradley, the State Mineralogist, with reference to the above enumerated bids, and to withhold further action on such bids until a statement is received from the State Mineralogist.

There being no further business to come before the Commission, the meeting was adjourned.
