Company's agreeing to extend the time within which the State might make formal objection to the 11th to the 37th revisions, inclusive, of the State's percentage allotment, to sixty days after the submission by Standard Oil Company, to the Commission, of the revised map of the Rio Vista Field which Standard Oil Company has agreed to submit.

- 6. (No. 91, P.R.C., Oil and Gas Lease.) Upon motion duly made and unanimously carried, a resolution was adopted confirming approval heretofore given by the Executive Officer, of that crude oil purchase agreement entered into by H. R. Hamilton, Operator, with respect to production from this lease, and the Standard Cil Company dated June 24, 1943. This approval is given subject to the right of the State to take its oil in kind as provided for under the terms of the lease.
- 7. (No. 91, P.R.C., Oil and Gas Lease.) Upon motion duly made and unanimously carried, a resolution was adopted wherein the action of the Executive Officer in approving the contract for treatment and sale of gas and gasoline produced from State land under the terms of No. 91, P.R.C. was confirmed. The treatment contract has been entered into by and between H. R. Hamilton, Operator, the State's Lessee, and the O. C. Field Gasoline Corporation as of July 31, 1943. This approval is given subject to the condition that the State reserves its right to take its gas and/or gasoline in kind as provided for under the terms of the lease.
- (No. 91, P.R.C., Oil and Gas Lease.) Upon motion duly made and unanimously carried, a resolution was adopted giving approval to the request dated August 5, 1943 of H. R. Hamilton, Operator and F. E. Fairfield, Partner, to assign as of July 10, 1943, an undivided one third interest to H. R. Hamilton, an undivided one third interest to the O. C. Field Gasoline Corporation an undivided one sixth interest to the Oil Tool Corporation and an undivided one sixth interest to F. E. Fairfield. Such approval is given subject to the reservation that no provisions of said Lease No. 91, P.R.C. are to be affected, and that a single agent shall be nominated by the above mentioned successors in interest under said assignment, and said single agent shall be the party with whom the State shall hereafter transact all business matters with respect to said lease and upon whom the State shall serve such notices as might become necessary during the term of said lease. Approval was further given to the instrument dated July 30, 1943 whereunder, H. R. Hamilton, Operator, the O. C. Field Gasoline Corporation by O. C. Field, President and H. A. Barrett, Assistant Secretary, F. E. Fairfield, the Oil Tool Corporation by F. E. Fairfield, President and Edna E. Sellers, Secretary assignees would jointly and severally assume and agree to perform all of the terms, covenants and conditions contained in said Oil and Gas Lease No. 91, P.R.C.
