

5. (Withdrawal and Readvertising of Seal Beach Field) Upon motion duly made and unanimously carried, a resolution was adopted approving the actions of the Executive Officer in withdrawing the notice of intention to receive bids for an area of submerged lands at Seal Beach, Orange County. The notice was advertised on November 10, 1943. The Resolution also authorized the readvertising of this area.
6. (P.R.C. No. 113, Division of Beaches and Parks) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to execute a lease with the Division of Beaches and Parks for occupancy of an area of submerged lands in Santa Cruz County. The area is occupied by an existing pier and stranded concrete ship hull. The Lease will run for a term of five years at a rental of \$100.00 per year. This Lease is to be given subject to the Division of Beaches and Parks assuming full responsibility for maintaining and operating the pier and ship and relieving the State Lands Commission of any liability that might accrue during the term of their occupancy prior and during the term of the Lease.
7. (Restitution Certificate No. 289 - Frank G. Sterrett) Upon motion duly made and unanimously carried, the Executive Officer was authorized to execute Restitution Certificate No. 289 in favor of Frank G. Sterrett in the sum of \$400.00. This amount is being refunded because the lieu land which was to be acquired by the State for Mr. Sterrett, had been withdrawn from entry by Executive order of the President of the U. S. A. on November 11, 1943.
8. (Grazing Lease Application No. 1070, P.R.C. - A. H. Newman) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the issuance of a grazing lease to A. H. Newman on the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ and the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 22, T. 27 N., R. 17 E., M.D.M., consisting of 160 acres in Lassen County for a term of five years at an annual rental of twenty-five cents per acre per year.
9. (Grazing Lease Application No. 1071, P.R.C. - Jose Bicondoa) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the issuance of a grazing lease to Jose Bicondoa on Section 16, T. 37 N., R. 17 E., M.D.M., consisting of 640 acres in Lassen County for a term of five years at an annual rental of twenty-five cents per acre per year.
10. (Grazing Lease Application No. 1115, P.R.C. - Guy Redwine) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the issuance of a grazing lease to Guy Redwine on Lot 8 in the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 27, and Lot 2, 3 and 7 of Section 34, T. 23 N., R. 15 W., M.D.M., consisting of 197.60 acres in Mendocino County for a term of five years at an annual rental of twenty-five cents per acre per year.
