

11. (Grazing Lease Application No. 1117, P.R.C. - A. E. Davis) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the issuance of a grazing lease to A. E. Davis on Lots 1, 2, 7 and 8 of Section 16, T. 1 S., R. 15 E., M.D.M., consisting of 120 acres in Tuolumne County for a term of five years at an annual rental of thirty-seven and one half cents per acre per year.
12. (Grazing Lease Application No. 1073, P. R.C. - James O. Fite) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the issuance of a grazing lease to James O. Fite on the N $\frac{1}{2}$, W $\frac{1}{2}$ of SW $\frac{1}{4}$, SW $\frac{1}{4}$ of NE $\frac{1}{4}$ and N $\frac{1}{2}$ of SE $\frac{1}{4}$ of Section 36, T. 5 S., R. 1 W., S.B.M., consisting of 360 acres in Riverside County for a term of five years at an annual rental of twenty cents per acre per year.
13. (Grazing Lease Application No. 1120, P.R.C. - E. N. Tooby) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the issuance of a grazing lease to E. N. Tooby on the NW $\frac{1}{4}$ of NW $\frac{1}{4}$, E $\frac{1}{2}$ of NW $\frac{1}{4}$, W $\frac{1}{2}$ of NE $\frac{1}{4}$, SE $\frac{1}{4}$ of NE $\frac{1}{4}$ and N $\frac{1}{2}$ of SE $\frac{1}{4}$ of Section 16, T. 5 S., R. 4 E., H. M., Consisting of 320 acres in Humboldt County for a term of five years at an annual rental of fifty cents per acre per year.
14. (Grazing Lease Application No. 1119, P.R.C. - D. D. Peebles) Upon motion duly made and unanimously carried, the application of D. D. Peebles to lease for grazing the NW $\frac{1}{4}$ of NW $\frac{1}{4}$, E $\frac{1}{2}$ of NW $\frac{1}{4}$, W $\frac{1}{2}$ of NW $\frac{1}{4}$, SE $\frac{1}{4}$ of NE $\frac{1}{4}$, N $\frac{1}{2}$ of SE $\frac{1}{4}$ of Section 16, T. 5 S., R. 4 E., H. M., consisting of 320 acres in Humboldt County for a term of five years at an annual rental of twenty-five cents per acre per year was rejected.

Jenkins Land & Livestock Company on the E $\frac{1}{2}$ of NW $\frac{1}{4}$, NE $\frac{1}{4}$ of SW $\frac{1}{4}$, SW $\frac{1}{4}$ of NE $\frac{1}{4}$, NE $\frac{1}{4}$ of NE $\frac{1}{4}$, SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 16, T. 37 N., R. 16 E., and the SE $\frac{1}{4}$ of NW $\frac{1}{4}$, SW $\frac{1}{4}$ of NE $\frac{1}{4}$, SW $\frac{1}{4}$ and W $\frac{1}{2}$ of SE $\frac{1}{4}$ of Section 36, T. 38 N., R. 15 E., M.D.M., consisting of 560 acres in Lassen County for a term of five years at an annual rental of twenty-five cents per acre per year.
16. (Extension Purchase Agreement for Location No. 3132, Independence, Caroline B. Payne) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the execution of an "Extension Agreement for Time With Which to Make Balance of Purchase Price of State School Land", covering land purchased under Certificate of Purchase No. 17196, Location No. 3132, Independence Land District, covering Section 36, T. 32 S., R. 43 E., M.D.M., consisting of 640 acres, subject to receipt of an opinion from the Attorney General that the forfeiture pursuant to Chapter 14 of 1937 may be withdrawn.
