- 5. (State Oil and Gas Lease No. 132, P.R.C., Gilco Imcorporated-Seal Beack) Upon motion duly made and unanimously carried, a resolution was adopted confirming the action of the Executive Officer in granting thirty days extension to Gilco Incorporated within which to commence the drilling of their first well.
- 6. (State Oil and Gas Lease No. 129, P.R.C. Signal Oil and Gas Company Elwood) Upon motion duly made and unanimously carried, a resolution was adopted confirming the action of the Executive Officer in granting thirty days extension to Signal Oil Company within which to commence drilling of their first well.
- 7. (Tideland Oil Drainage Santa Barbara Mesa Oil Field Santa Barbara County) Upon motion duly made by Governor Houser, seconded by Commissioner Riley and unanimously carried, a resolution was adopted authorizing the Executive Officer to advertise for bids for lease of tide and submerged land adjacent to the presently producing upland at Santa Barbara Mesa; subject to including in the advertising the provision that all surface locations for drilling into the State land must have the approval of the Executive Officer in order to protect the beach for bathing and scenic features of the area involved.
- 8. (Tideland Oil Drainage Summerland Santa Barbara County)
 Upon motion duly made by Governor Houser, seconded by Commissioner
 Riley and unanimously carried, a resolution was adopted authorizing
 the Executive Officer to advertise for bids for lease of tide and
 submerged land adjacent to the presently producing upland as Summerland; subject to including in the advertising the provision that
 all surface locations for drilling into the State land must have the
 approval of the Executive Officer in order to protect the beach for
 bathing and scenic features of the area involved.
- 9. (Authorization for Advertising for Bids for Oil Lease of Ungranted Tidelands El Segundo) Upon motion duly made and unanimously carried, the Executive Officer was authorized to advertise for bids for lease of ungranted tidelands adjacent to the oil development area at El Segundo, Los Angeles County; subject to including in the advertising the provision that all surface locations for drilling into the State land must have the approval of the Executive Officer in order to protect the beach for bathing and scenic features of the area involved.
- 10. (Assignment of Fish Canyon Lease No. 648) Upon motion duly made and unanimously carried, a resolution was adopted approving execution of the assignment of this lease by W. J. Knecht to William F. Commerford.
- 11. (Cancellation of Fish Canyon Lease No. 637) Upon motion duly made and unanimously carried, a resolution was adopted instructing the Executive Officer to notify Mr. B. V. Brasher, the Lessee of Lease No. 637 Fish Canyon that said lease had been cancelled pursuant to the statutes because of his failure to pay the annual rental due January 1, 1944 within the statutory fifteen day period.
