

11. (Application to Purchase Vacant School land in SW $\frac{1}{4}$ of SE $\frac{1}{4}$ and Lot 8 of Section 27, and Lots 2, 3, and 7 of Section 34, T. 23 N., R. 15 W., M.D.M.) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the advertisement for the cash sale of 197.60 acres of School land in SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Lot 8 of Section 27, and Lots 2, 3, and 7 of Section 34, T. 23 N., R. 15 W., M.D.M., in Mendocino County, to the highest bidder. The advertisement shall stipulate that no bids will be accepted for less than \$6.00 per acre.

12. (Application to Purchase Timberland in SE $\frac{1}{4}$ of SW $\frac{1}{4}$ and NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 2, T. 2 N., R. 16 E., M.D.M.) 13. (Assignment of Gorge Madera Lease No. 124, P.R.C.) Upon motion duly made and unanimously carried, a resolution was adopted approving the assignment of Lease No. 124, P.R.C. from Henry C. Will to Mrs. J. Zimmerman.

14. (Application for Permit to Construct a Forty-Inch Outfall Sewer Over Tide and Submerged Land No. 147, P. R. C.) Upon motion duly made and unanimously carried, a resolution was adopted approving the issuance of a cost free permit to the City of Oxnard to construct a forty inch outfall sewer line over tide and submerged lands adjacent to Hueneme, Ventura County.

A letter was read from the State Controller in which he stated that the sum of \$325,000.00 should be transferred from the State Lands Act Fund to the General Fund, State Beach Fund and State Park Fund in percentages of 30, 23 $\frac{1}{3}$, and 46 $\frac{2}{3}$, respectively.
