A meeting of the State Lands Commission was held in Room 306, State Capitol, Sacramento on April 17, 1945 at 10 A. M.

1. Upon motion duly made and carried, the minutes of the regular meeting of the State Lands Commission held in Los Angeles on February 20, 1945, were unanimously approved and confirmed as submitted.

2. Upon motion duly made and carried, it was tentatively decided to hold the next meeting of the Commission in Sacramento on May 15, 1945 at 10 A. M.

3. (Fourth Partial Assignment of State Oil and Gas Lease No. P.R.C. 91) Upon motion duly made and unanimously carried, the State Lands Commission confirmed the approval heretofore given by the Executive Officer for the drilling of the first and second wells (Nos. 20 and 21) under the Fourth Partial Assignment of State Oil and Gas Lease No. P.R.C. 91. The assignment is dated February 7, 1945. Approval of this assignment was given to the Huntington State Company providing satisfactory evidence is submitted to the Commission that the excessive curtailment of oil production is in the interests of the State.

Under this assignment, the Huntington State Company receives from H. R. Hamilton, Mildred L. Hamilton, F. E. Fairfield, Ruth Fairfield, The Oil Tool Corporation, the Fullerton Oil Company, Kenneth D. Dawson, Louise A. Dawson, W. T. Sexton and Marguerite L. Sexton, as Lessees under Lease No. P.R.C. 91, all rights and privileges to prospect for, drill for, and remove oil and gas from not more than six additional wells to be drilled in accordance with the provisions of Lease No. P.R.C. 91.

This approval is further contingent upon agreement by the lessees and assignees or any successors in interest, to continue to assume all liability and responsibility for compliance with all the terms, provisions and conditions of said Lease No. P.R.C. 91, and exhibits thereof.

4. (Agreement No. 415 - Standard Oil Company) Upon motion duly made and unanimously carried, a resolution was adopted confirming the Executive Officer's approval of the 53d Revision of the State's participating interest in the productive areas of the Rio Vista Field. Under the revision, the State's participating interest is as follows:

This approval is granted subject to any change which might result in necessary adjustments of the basic acreage figures to be agreed upon with respect to the 11th and 12th Revisions, and is further subject to the Standard Oil Company's agreeing to extend for a period of sixty days after the submission by the Standard Oil Company to the Commission of the revised map of the Ric Vista Field which the Standard Oil Company has agreed to submit, the time within which the State might make formal objection to the 11th to 53d Revisions, inclusive, of the State's percentage allotment.

5. (Seal Beach Area - Bid Pursuant to Advertising for Oil Lease) Messrs. A. T. Jergins and Allen Jergins appeared before the Commission in connection with a bid submitted on April 10, 1945 by the Marine Exploration Company at a bid factor of 1.1 and dovering an area of land which had been advertised for lease at Seal Beach, California.

After a full discussion of the whole situation of tideland oil development at Seal Beach, the Commission decided to defer action on the bid until the meeting to be held May 15th. 1945.

6. (Pacific Gas and Electric Company Application for a 6 5/8 Inch Gas Line Crossing Under Sacramento River - No. P.R.C. 176) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the issuance of a fiftsen year right of way easement five hundred feet in length to the Pacific Gas and Electric Company for a 6 5/8" gas line crossing under the Sacramento River in Butte and Glenn Counties upon the following terms and conditions:

- a. Payment by the Pacific Gas and Electric Company of an annual rental of \$50.00.
- b. Filing with the Comm. ssion of a satisfactory faithful performance bond.
- c. Filing of a detailed map as required by Regulation A. Rule 223.

7. (Pacific Gas and Electric Company Application for an Overhead Wire Crossing Over the San Joaquin River near Stockton - No. P.N.C. 177) Upon motion duly made and unanimously carried, a resolution was adopted authomizing the issuance of a fifteen year right of way easement two hundred and fifty in length to the Pacific Gas and Electric Company for an Overhead 50 KV electric power extension to serve the United States Navy on Rough and Ready Island, Stockton, San Joaquin County upon the following terms and conditions:
