

16. (Application for Construction of a Dredging Fill in Mission Bay- Division of Water Resources - No. P.R.C. 199) Upon motion duly made and unanimously carried, a resolution was adopted confirming the action of the Executive Officer in granting a permit to the Division of Water Resources, Department of Public Works for dredging an area in Mission Bay, San Diego County and depositing of spoils for construction of a fill.

This permit was issued pursuant to application prior to the time of the granting of these tide and submerged lands to the City of San Diego, pursuant to Chapter 142 of the Statutes of 1945.

17. (Permit for Exploration and Sampling of Minerals - No. P.R.C. 155) Upon motion duly made and unanimously carried, the Executive Officer was authorized to issue a permit to Ernest Hey, for exploration, sampling and testing of any minerals, exclusive of oil or gas, contained within an area lying offshore from Humboldt and Del Norte Counties, and more particularly described as follows:

Commencing at a point at the intersection of the mean high tide line of the Pacific Ocean and the South line of Township 15 N., H.B.M.; thence Westerly along the prolongation of said Southerly line of T. 15 N., H.B.M., a distance of 1,000 feet into the Pacific Ocean, the true point of beginning; thence Southerly on a line parallel and concentric to the mean high tide line of the Pacific Ocean to a point in the Pacific Ocean 1,000 feet seaward from the mean high tide line of the Pacific Ocean, where this line intersects a prolongation of the South line of T. 9 N., H. B.M.; thence Westerly along the prolongation of this township line 14,840 feet to a point in the Pacific Ocean; thence Northerly along a line parallel and concentric to said mean high tide line of the Pacific Ocean to the point of intersection with the prolongation of the Southerly line of T. 15 N., H.B.M.; thence Easterly 14,840 feet to the true point of beginning, and containing approximately 68,400 acres.

The permit shall contain provisions whereunder the Permittee will not be permitted to operate or explore closer than 1,000 feet from the mean high water mark. All minerals or materials removed from such lands shall be the property of the State of California.

The Permittee is to render quarterly confidential reports to the Commission containing results of Permittee's findings and operations. The term is 180 days from issuance of the permit with 180 day renewal privilege to permittee.

18. (Right of Way - Pacific Gas & Electric Company over Section 36, T. 12 N., R. 25 W., S.B.M.) The Commission discussed a letter from Mr. A. Emory Wishon, Vice President and General Manager of the Pacific Gas & Electric Company, wherein Pacific Gas & Electric Company protested against the State Lands Commission policy for annual rental for rights of way granted over State school lands.

Upon motion duly made and unanimously carried, a resolution was adopted reaffirming the Commission's policy of requiring grantees to pay \$10.00 annual minimum rental, plus two cents for each lineal foot of right of way and fifteen year term.

19. (Sale of Vacant School Land, Application No. 10302, Los Angeles Land District - Riverside County) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale for \$1,600.00 cash of the S $\frac{1}{2}$ of SW $\frac{1}{4}$ and S $\frac{1}{2}$ of SE $\frac{1}{4}$ of Section 16, T. 7 S., R. 1 E., S.B.M., consisting of 160 acres in Riverside County to Alexander Aldrich. Mr. Aldrich was the only bidder pursuant to the advertising. This land is to be sold subject to statutory reservations including minerals.

20. (Sale of Vacant School Land, Application No. 10304, Los Angeles Land District - San Diego County) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale for \$160.00 cash of the N $\frac{1}{2}$ of SW $\frac{1}{4}$ of Section 36, T. 16 S., R. 2 E., S.B.M., consisting of 80 acres in San Diego County to T. B. Smiley. Mr. Smiley was the only bidder pursuant to the advertising. This land is to be sold subject to statutory reservations including minerals.

21. (Sale of Vacant School Land, Application No. 4546, Sacramento Land District - Shasta County) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale for \$1,440.00 cash of the N $\frac{1}{2}$ and N $\frac{1}{2}$ of S $\frac{1}{2}$ of Section 16, T. 29 N., R. 9 W., M.D.M., consisting of 480 acres in Shasta County to H. Burch. Mr. Burch was the only bidder pursuant to the advertising. This land is to be sold subject to statutory reservations including minerals.
