The annual rental for said easement is to be \$52.20 in accordance with the uniform /policy of the Commission and the issuance of the easement is subject to the filing of a \$3,000 corporate surety bond by Pacific Public Service Company to guarantee performance and the removal of any structures at the termination of the easement.
