

6. (Request for Permission to Install Temporary Cable Crossing - Klamath River - Metro-Goldwyn-Mayer Studios - No. P.R.C. 256) Upon motion duly made and unanimously carried, a resolution was adopted confirming the permission previously given to the Metro-Goldwyn-Mayer Studios for the installation of a cable across the Klamath River for use in transporting materials for a motion picture location, for a period not to exceed sixty days, said permit to be issued for no consideration other than the statutory filing fee of \$5.00.

7. (Tide and Submerged Lands - Gas Pipe Line Crossing Mokelumne River - Pacific Gas and Electric Company) Upon motion duly made and unanimously carried, a resolution was adopted holding in abeyance the issuance of a temporary right of way permit to the Pacific Gas and Electric Company for a proposed gas pipe line crossing under the Mokelumne River in San Joaquin and Sacramento Counties three miles northeast of Thornton, pending the entering into of a compensatory royalty agreement with the companies having gas wells that would drain State land in the Thornton Gas Field.

8. (Leasehold Condemnation Action No. 540 SD, Civil) The Commission was informed that the Navy's renewal on Action 540 SD Civil, a leasehold taking on the area of tide and submerged lands which were filled by the Navy in San Diego Bay, had expired on June 30, 1946. The Navy has suggested that disposition of the action and consequent restoration of clear title to the State could be achieved most expeditiously by acceptance of the State Lands Commission of a nominal rental consideration for the period said lands were held by the Navy.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the acceptance of a nominal rental consideration of \$1.00 per year for the period during which the United States Navy held 138 acres of filled tide and submerged lands in San Diego Bay under leasehold taking No. 540 SD, Civil, this area being that certain Parcel "F" shown on Public Works Drawing No. ND/NI-9 (42) of the Eleventh Naval District.

9. (Notice of Intention to Receive Bids for Extraction of Sand from Shoals in San Francisco Bay - Bid of Construction Aggregates Corporation No. P.R.C. 259) Upon motion duly made and unanimously carried, a resolution was adopted awarding to the Construction Aggregates Corporation, the only bidder, a one-year non-exclusive mineral lease for the extraction of sand from Fort Knox and Alcatraz Shoals in San Francisco Bay, pursuant to bid filed in accordance with the Notice of Intention of the State Lands Commission to receive bids as published in the San Francisco Examiner and the San Rafael Independent on Thursday, August 29, 1946. The lease provides for a payment to the State of a royalty of three cents per cubic yard of sand extracted from the following described State lands:

That portion of Presidio Shoals in the County of San Francisco, as shown in Public Notice No. 2, United States Engineer Office, San Francisco, dated 22 July 1946, lying westerly of the extension northerly of the center line of Webster Street, San Francisco and Fort Knox Shoal in the County of Marin, as shown in Public Notice No. 2, United States Engineer Office, San Francisco, dated 22 July 1946.

This non-exclusive mineral lease was awarded subject to the filing of a corporate surety bond in the amount of \$5,000.00 to guarantee faithful performance under the lease.
