Clark) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of the SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 16, T. 18 S., R. 2 E., S.B.M., containing 40 acres in San Diego County at a cash price of \$80.00 to Mr. Fred R.
