20. (Application to Dredge from Tide and Submerged Lands - San Francisco Bay, San Mateo County - W. O. 111) The Commission was informed that an application had been received from Johnson Western-American for a prospecting permit for the development of deposits of sand, clay and gravel to be dredged from San Francisco Bay in San Mateo County southerly from the San Francisco Airport; and that title to a portion of the area for which a prospecting permit is desired is in question and may have been conveyed without authority by the State prior to 1870.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Acting Executive Officer, in conjunction with the office of the Attorney General, to execute and issue to the Johnson Western-American a prospecting permit as applied for and to establish the royalties to be paid under any preferential loase issued as a condition subsequent to the prospecting permit of three cents per cubic yard for commercial materials removed from the State land and to provide that any royalties so paid be placed in escrow for disbursement to the legal owner as established by the outcome of a quiet title action to be filed against the purported owner of the subject land.

- 21. (Sale of Federal Land Obtained Through Use of Base) Upon motion duly made and unanimously carried, a resolution was adopted approving the filing of the indemnity selection of the lands with the Bureau of Land Management and the sale of the lands obtained thereby to the original applicants at the stated total value as shown on the attached Appendix "A".
- 22. (Sale of Vacant School Land, Application No. 4584, Sacramento Land District Wiskiyou County Clarence Dudley) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of Section 16, T. 41 N., R. 8 W., M.D.M., containing 640 acres in Siskiyou County at a cash price of \$3,600.00 to Mr. Clarence Dudley. Mr. Dudley was the only bidder pursuant to the advertising. The land is to be sold subject to all statutory reservations including minerals.
- 23. (Sale of Vacant School Land, Applications Nos. 4585 and 4586; Sacramento Land District Shasta County Ed. Bathurst and Ray Meyer) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of Section 16, T. 33 N., R. 3 W., N.D.M., containing 640 acres in Shasta County at a cash price of \$5,000.09 to Ed. Bathurst, the original applicant. Alternatively, if Mr. Bathurst fails to meet the high bid of Mr. Ray Meyer then the land shall be sold to Mr. Meyer. The land is to be sold subject to all statutory reservations including minerals.
- 24. (Sale of Vacant School Land, Application No. 4587, Sacramento Land District Modoc County Frank L. Asta) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of Lots 1, 2, 3, 4, E2 of NE4 and E2 of SE4 of Section 36, T. 43 N., R. 16 E., M.D.M., containing

242.82 acres in Modoc County at a cash price of \$728.46 to Mr. Frank L. Asta. Mr. Asta was the only bidder pursuant to the advertising. The land is to be sold subject to all statutory reservations including minerals.

25. (Sale of Vacant School Land, Application No. 4588, Sacramento Land District-Santa Clara County - Henry Sutcliffe Coe) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of Let 9 of Section 33, T. 8 S., R. 4 E., M.D.M. Lontaining 37.84 acres in Santa Clara County at a cash price of \$240.00 to Mr. Henry Sutcliffe Coe. Mr. Coe was the only bidder pursuant to the advertising. The land is to be sold subject to all statutory reservations including minerals.

26. (Sale of Vacant School Land, Application No. 10343, Los Angeles Land District = Riverside County = C. N. Parker) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of the NFL, W2 of SWL, SWL of NEL and N2 of SEL of Section 36, T. 5 S., R. 1 W., S.B.M., containing 360 acres in Riverside County at a cash price of \$1,440.00 to Mr. C. N. Perker. Mr. Parker was the only bidder pursuant to the advertising. The land is to be sold subject to all statutory reservations including minerals.

27. (Sale of Vacant School Land, Application No. 10347, Los Angeles Land District - San Diego County - Ethel G. Westerfield) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of the SW of NE of Section 36, T. 16 S., R. 1 E., S.B.M. containing 40 acros in San Diego County at a cash price of \$200.00 to Mrs. Ethel G. Westerfield. Mrs. Westerfield was the only bidder pursuant to the advertising. The land is to be sold subject to all statutory reservations including minerals.

28. (Auxiliary Landing Field, Victorville Air Base, Los Angeles County - War Dpartment - W. O. 94) The Commission was informed that in the negotiations for the termination of the lease for Section 36, T. 6 N., R. 8 W., S.B.B. & M., formerly occupied by the United States Army as an auxiliary air field, that the War Department had offered to leave the landing field runways and drains in place in lieu of restoring the premises to the original condition as required by the lease, but that the fence around the property installed by the War Department would be removed.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Acting Executive Officer to approve the acceptance from the War Department of Section 36, T. 6 N., R. 8 W., S.B.B. & M., Los Angeles with all existing airport facilities except the field fence in place, in lieu of restoration of the land by the War Department to its original condition, and to advertise said area for bias for a lease for airport purposes.
