5. (Geophysical Exploration Permit - The Texas Company - Santa Barbara County - No. P. R. C. 327) The attention of the Commission was invited to the fact that on September 19, 1947, authorization was given for the issuance of a permit to The Texas Company for the conduct of geophysical exploration operations on submerged lands between the Santa Barbara breakwater and Point Conception, Santa Barbara County, during the period September 21, 1947 to December 20, 1947, subject to the specific condition that such operations be conducted only pursuant to a valid permit by the Division of Fish and Game authorizing the use and discharge of the requisite explosives.

The Commission was informed that the Texas Company now advises that they were unable to complete their offshore geophysical operations and have requested an extension of the permit for an additional period of ninety days, or until March 20, 1948. The Division of Fish and Camp has granted an extension under specified conditions.

Upon motion duly made and unanimously carried, a resulution was adopted authorizing the extension of Permit No. P.R.C. 327, is sued to the Texas Company for geophysical exploration, for an additional ninety days or until March 20, 1948, subject to the compliance of the permittee with the requirements of the Division of Fish and Game.

6. (Application for Right of Way Across School Lands - County Board of Supervisors - Mono County W. O. No. 227) The Commission was advised that an application has been received from the Beard of Supervisors of Mono County for a right of way easement over a portion of the No of Section 36, T. 3 N., R. 26 E., M. D. B. & M., Mono County, pursuant to Chapter 630 of the Statutes of 1865-1866 which provides for the authorization of the construction of county roads across State lands.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to execute and issue a right of way easement to the County Board of Supervisors of Mono County for the 100-foot right of way desired.

7. (Revised Application for Mineral Prospecting Permit - Harry F. Heather - San Bernardino County - W. O. No. 217) The revised application of Mr. Harry F. Heather for permission to prospect for clay and other non-metallic substances on Lots 5, 6 and 7 and the SET of NWT of Section 36, T. 9 N., R. 4 E., S.B.M., consisting of 161.16 acres in San Bernardino County was presented in lieu of the application for permission to prospect on Lots 3, 4 and 5 and the SET of the NWT of Section 36, T. 9 N., R. 4 E., S.B.M., consisting of 152.87 acres as approved by the Commission on December 1, 1947.

After consideration of a possible conflict of the revised area as applied for with another permit application filed heretofore, upon motion duly made and unanimously carried, a resolution was adopted authorizing the execution and issuance of a prospecting permit to Mr. Harry F. Heather on Lots 5, 6 and 7 and the SE of NE of Section 36, T. 9 N., R. 4 E., S.B.B. & M., consisting of 161.16 acres subject to the requirements of the Public Resources Code and the same royalty terms and conditions as approved prevaiously on December 1, 1947 for the authorized prospecting permit on Lots 3, 4 and 5 and the SE of the NW of Section 36, T. 9 N., R. 4 E., S.B.M., consisting of 152.87 acres. The execution and issuance of the revised prospecting permit is to be made only upon the establishment of the fact that there is no conflict in the subject area descriptions with any other currently existing application for a prospecting permit.

8. (Assignment of Lease No. P.R.C. 258 - Vidal Junction - San Bernardino County - from Oscar Simon to K. Sonald Wren) The Commission was informed that Lease No. P.R.C. 258 was authorized on August 22, 1946, ...asing 14.5 acres of the SW of W of Section 9, T. 1 N., R. 23 E., S.B.M., to C. R. Johnson, which lease was assigned subsequently to Oscar Simon. Attention was called also to the fact that Mr. Simon has had a stroke which has partially paralyzed him, necessitating sale of his improvements on this State property.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to approve the assignment of Lease No. P.R.C. 258 from Oscar Simon to K. Donald Wren, upon payment of the statutory \$5.00 filing fee, heretofore paid to the State.

9. (Assignment of Lease No. P.R.C. 339 - Videl Junction - San Bernardino County - from Oscar Simon to K. Donald Wren) The attention of the Commission was directed to the fact that Lease No. P.R.C. 339 was authorized on December 1, 1947, leasing 1.2 acres in the Swa of Nwa of Section 9, T. 1 N., R. 23 E., S.B.M., to Oscar Simon.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to approve the assignment of Leass No. P.R.C. 339 from Oscar Simon to K. Donald Wren, upon payment of the statutory \$5.00 filing fee, heretofore paid to the State.

10. (Sale of Vacant School Land, Application Nos. 4614, and 4631, Sacramento Land District - El Dorado County - Francis I. Leach) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of Wa of Sale o
