

15. (Application for sublease, Lease P.R.C. No. 4, Radio Diablo, Inc., Contra Costa County, W.O. 457) The Commission was informed that an application has been received from Radio Diablo, lessee under Lease P.R.C. No. 4 of 59.62 acres on Mt. Diablo, Contra Costa County, for permission to sublease to the Lenkurt Electric Company, in accordance with the terms of Lease P.R.C. No. 4, 30 square feet of floor space in the building of Radio Diablo, Inc. Such sublease is for the sole purpose of permitting the installation and operation of high frequency multi-channel communication circuits on an experimental basis.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to approve the proposed sublease from Radio Diablo Inc. to the Lenkurt Electric Company pursuant to the terms and conditions of Lease P.R.C. No. 4, subject to the condition that a copy of any notice of termination of the sublease be transmitted to the State Lands Commission and further subject to the condition that no objection is made by the Division of Communications to the sublease.

16. (Travel Expenses - One Day Trips - Division of State Lands - Accounting)

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the State Lands Commission to rescind its action of September 19, 1947, which action was adopted as Minute Item 24, and duly recorded on Page 784, of the Minutes of the State Lands Commission, and that the allowance or disallowance of claims for noon meals on one day trips be left to the discretion of the Executive Officer provided approval is consistent with the Board of Control rules.

17. (Revision of Minutes of the State Lands Commission, Minutes of December 10, 1948, adopted in Item 1, Minutes of the meeting of the State Lands Commission, February 25, 1949) The Commission was informed of a duplication in the wording of Item 45 in the minutes of the meeting of the State Lands Commission of December 10, 1948.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the following language to be substituted for that appearing in the Minutes of December 10, 1948, meeting, Item 45: That the powers granted to Colonel Robert C. Hunter be rescinded as of November 15, 1948, the date of his separation from State service, and that these same powers, as appointing authority of the State Lands Commission, Division of State Lands; the right to execute claims to the Controller for payment; and to authorize withdrawals and transfers from the Cash State, Revolving Fund, and Payroll revolving Fund, Bank Accounts; be conferred upon Rufus W. Putnam, the Executive Officer as of November 16, 1948. It is further resolved that the powers heretofore granted in this regard to Messrs. Watson, Hortig and Porter be continued.

18. (S.B. 1520) The Commission was informed that the Senate Committee on Governmental Efficiency, Ralph D. Swing, Chairman, has requested a report from the Commission with respect to S.B. 1520 which is to amend Section 126 of the Government Code. This section of the Government Code has to do with jurisdiction of the United States over lands acquired by it in the State. A draft of proposed report was submitted for consideration by the Commission.

Upon motion duly made and unanimously carried a resolution was adopted authorizing the Executive Officer to submit the report as discussed on S.B. 1520.
