Upon motion duly made and unanimously carried, a resolution was adopted authorising the Executive Officer to issue to Standard Oil Company of California, a right of way easement 50 feet in width and approximately 2507 feet in length over tide and submerged land of the Pacific Ocean near Carpinteria, Santa Barbara County, at the regulatory annual rental of \$40.00 plus 2 cents per lineal foot for a period of fifteen years with right of renewal for an additional ten years at such rent as may be determined by the Commission prior to renewal and upon furnishing by the Company of a \$1,000,00 bond.

6. (Pacific Gas and Electric Company - Application for easement over tide and submerged lands - San Joaquin River, Contra Costa County - P.R.C.115) The Commission was informed that on June 14, 1949, the Commission authorized the issuance of a right of way easement 100 feet in width to Pacific Gas and Electric Company extending 252 feet into San Joaquin River in Contra Costa County near Antioch for a period of twenty years at an annual rental of \$15.00 with right of renewal for three additional periods of ten years each at such terms as shall be determined by the Commission at time of renewal. The Company has now revised their plans by the addition of protective dolphins riverward of the easement authorized. In order to include these dolphins an extension of the easement to a length of 266 feet and a corresponding increase in rental to \$45.32 per year is called for.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the revision of Item 16 of the Minutes of June 14, 1949, by striking the number 252 and replacing by the number 266 as the length in feet and striking the amount \$45.04 and replacing by \$45.32 as the annual rental.

7. (County of San Mateo - Application for lease of portion of Guadalupe Canal. San Mateo County - W.O. 392 - P.R.C. 412) The Commission was informed that on December 10, 1948, the Commission authorized issuance of a lease to San Mateo County of approximately 10.23 acres of tide and submerged land in Guadalupe Canal, including that portion of the former Visitacion Avenue which lay in Guadalupe Canal. Upon preparation of lease forms the staff found that the former Visitacion Avenue area was covered by an easement to the County of San Mateo for highway and public utility purposes under Chapter 675, Political Code. This easement contains no time limit or reversionary clause. It is still used for a public utility, an outfall sewer. The area of 10.23 acres was also found to be erroreous, the actual area being 5.45 acres more or less.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Commission to approve the correction of Item 14 of the December 10, 1948 Minutes, by striking the figure "10.23 acres" substituting therefor "5.45 acres more or less" and also striking "South line of former Visitacion Avenue", substituting therefor "North line of former Visitacion Avenue", all other conditions to remain unchanged.

8. (City of San Diego - Application for permit to construct piers and install mooring markers in San Diego Bay - W.O. 5h6, P.R.C. h57) The Commission was informed that the Harbor Department of the City of San Diego has applied for a permit to construct three piers and two mooring markers in San Diego Bay bayward of the pierhead line in the Commercial Basin. The three piers are planned to extend 290 feet beyond the pierhead line for use by small craft.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to issue a permit to the City of San Diego to construct, maintain and use three piers extending 290 feet bayward of the pierhead line and install two piles marking the morning area in the Commercial Basin of San Diego

Bay for a period of fifteen years with right of rememal for an additional pariod of on years, no fees, deposit or rental being required.

9. (E. E. Ferrari - Application for lease in the Old Bed of San Joaquin River, San Joaquin County - W.O. 466, P.R.C. 458) The Commission was informed that Mr. E. E. Ferrari has applied for a lease of 46.62 acres in the old bed of the San Joaquin River to be used for a gum club. The srow applied for is approximately ten miles downstream from the city of Stockton. Rental will be the minimum of \$50.00 per year based on the appraised value of \$15.00 per acre. Filing fee and expense deposit have been paid.

Upon motion duly made and unanimously carried, a resolution was adopted authoriging the Executive Officer to issue a lease to Mr. 3. K. Ferrari of 46.62 acres in the old bed of the San Jesquin River known as Farcels 17 A-S and 17 C-S, San Joaquin County, to be used for a gum club for a period of five years at an annual rental of \$50.00 with right of renewal for an additional period of five years at such rental as may be determined, no bond being required, subject to receipt of waivers from the littoral owners.

NO. (Pacific Cas and Electric Company application for right of way easement across San Joaquin River at Kerman - W.O. 515, P.B.C. 153) The Commission was informed that Pacific Cas and Electric Company has applied for a right of way easement 100 feet in width and 350 feet in length across San Joaquin River at Kerman, Madera County and in Freeno County, to be used for the installation and maintenance of a gas line. Poriod of lease requested is fifteen years with right of renewel for three additional periods of ten years each. Regulatory rental will amount to \$17.00 per annua.

Upon motion duly made and unanimously carried, a resolution was adopted authorising the Executive Officer to issue to Pacific Ces and Electric Company a right of way essement 100 feet in width and 350 feet long across San Joaquin River in Madera and Fresno Counties for a period of fifteen years with right of renewal for three additional periods of ten years each for installation, maintenance and use of a gas line at an annual rental of \$47.00 for the initial period and at such rental as may be determined upon expiration of the initial period, bond in amount of \$1,000 to be included under the \$50,000 bond heretofore furnished.

II. (K. L. Springer - Application for Lease in the Old Bed of San Josquin River, San Josquin County - W.O. 520, P.R.C. 460) The Commission was informed that Mr. K. L. Springer has applied for a lease of 14.80 acres in the old bed of the San Josquin River to be used for a gun club. The area applied for is approximately ten miles downstream from the City of Stockton and across the Deep Water Channel from the area applied for by E. E. Ferrari, (Item 9 of these Minutes). Rental will be the minimum of \$50.00 per year, based on the appraised value of the area in the Ferrari application. Filing fee and expense deposit have been paid.

Upon motion duly made and unanimously extried, a resolution was adopted authorizing the Executive Officer to issue a lease to Mr. K. L. Springer of 14.80 acres in the old bed of the San Joaquin River known as parcel 17 B-S, San Joaquin County, to be used for a gun club for a period of five years at an annual rental of \$50.00 with right of renewal for an additional period of five years at such rental as may be determined, no bond being required, subject to receipt of waivers from the littoral owners.
