

A meeting of the State Lands Commission was held in Room 306, State Capitol, Sacramento, on November 21, 1949, at 9:30 a.m.

1. Upon motion duly made and unanimously carried, the minutes of the meeting of September 15, 1949, were approved and confirmed as submitted.
2. Upon motion duly made and unanimously carried, the dates of December 20 and 21 were suggested for holding the December meeting, the specific hour and date to be decided later.
3. Presentation was made by the Executive Officer to the Commission of a streamlined version of portions of the calendar covering (1) leases of tide and submerged lands, (2) applications for right of way easements, (3) and sale of vacant Federal, School or Lieu lands.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing future presentation of such streamlined calendar.

4. (Standard Oil Company of California - Revision 38 and 39 (Pool Basis) - Agreement for Easement No. 415 (303-21) - Rio Vista) The Commission was informed that the Standard Oil Company of California, lessee of the State's lands in the Rio Vista gas field under Agreement for Easement No. 415, has submitted for approval Revisions No. 38 and No. 39 to the State's allotment of productive lands. The data and computations for these revisions have been reviewed and found to be correct and reasonable. Comparison of the proposed revised allotments to the State lands under Agreement for Easement No. 415 and the data through the 39th Revision is as follows:
