Inspection of the land in Section 16, T. 10 N., R. 13 W., S.B.M., indicates that it is flat, sandy silt, well covered with brush. It lies approximately seven miles south and six miles west of Mojave in the Tehachapi Mountains immediately adjacent to a hard surface road. There are no water holes or streams on the land and no wells within several miles. The Assessor of Kern County has assessed contiguous land at \$2.50 per acre. An appraisal by a member of the Commission's staff indicates that the value of this land is \$2.50 per acre.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of the E2 of NE1 of Section 16, T. 30 S., R. 37 E., M.D.B. & M., and SE1 of SE1 of Section 16, T. 10 N., R. 13 W., S.B.B. & M., containing in the aggregate 120 acres to the City of Los Angeles, Department of Water and power, at a cash price of \$260.00 without advertising, subject to receipt of filing fee, appraisal costs, and purchase price and all statutory reservations including minerals.

32. (Application for lease to mine sand and gravel, Feather River - G. Oliver - W.O. 260) The Commission was informed that action on the application of February 25, 1946, of Graydon Oliver for a lease to mine sand and gravel from the Feather River near Marysville was originally withheld pending completion of a similar application by Boyd Oliver under W.O. 250, which application has now been cancelled at the request of the applicant after failure to secure a U. S. Engineer District permit to cover dredging within a navigable river. Graydon Oliver has again requested processing of application W.O. 260. The U.S. Engineer District Office has stated that they will interpose no objection to any removal of material from the channel within the limits of the U.S.E.D. navigation project provided that the proposed work is covered by a Department of the Army permit.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the publication of a Notice of Intention to Receive Bids for the extraction of sand and gravel at a royalty of not less than \$0.03 per cubic yard from 80 acres of the bed of the Feather River as applied for by Graydon Oliver on February 25, 1948, under W.O. 260, operations to be subject to a Department of the Army permit.

33. (Sale of vacant School land, application No. 4715, Sacramento Land District, Inyo County - City of Los Angeles - Sac. W.O. 202) The Commission was informed that an offer has been received from the City of Los Angeles to purchase the SW4 of Sw4 of Section 1h, T. 13 S., R. 35 E., and the W2 of Section 16, T. 14 S., R. 35 E., N.D.M., containing 360 acres in Inyo County. The City of Los Angeles has made an offer of \$600.00 or \$15.00 per acre for the SW4 of SW4 of Section 1h,

T. 13 S., R. 35 E., M.D.M. The Assessor of Inyo County has assessed contiguous lands at \$16.50 per acre, thus indicating an appraised value of the land at \$33.00 per acre. However, this assessment is based on the fact that the contiguous area was a going ranch acquired by the City of Los Angeles under which taxes are collected at values determined by the early use. The ranch is not now in operation. No taxes are levied on lands of acquisition which at the time are not on the assessment rolls. An appraisal by the Commise is a staff indicates that the offer made by the City of Los Angeles is adequate for the State land under present use in the area. This land is comparatively level, although there are several gullies or washes where the water runs during storms. Most of the land consists of hummocks, making it very rough and quite expensive to level in order to prepare it for cultivation. The greater portion of the land has more or less alkali on it. In places it has a heavy crust of alkali on it covering the surface. The land is covered with small sage brush and bunch grass and could be used for pasture. The soil appears to be of fair quality, except where there were washes and not too much alkali. It is doubtful whether the land would be suitable for cultivation without artificial irrigation. Water could be procurred through the drilling of :wells, as there is considerable swampy land nearby.

The City of Los Angeles has made an offer of \$1600.00 or \$5.00 per acre for the W2 of Section 16, T. 14 5., R. 35 E., M.D.M. The Assessor of Inyo County stated that the minimum assessment of \$2.00 per acre would be placed on this land if it were assessed, thus indicating an appraised value of \$4.00 per acre. An appraisal by the Commission's staff indicates that the offer made is adequate. This land lies on an alluvial slope, about three miles from the base of the hills and immediately south of Manzanar on Highway 395. It is accessible by road only through locked gates on the E2 of the section owned by the City of Los Angeles. The soil is rocky, second rate, but would be suitable for cultivation if irrigated. The land is covered with sage brush. Bear Creek runs through the section.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of the  $SW_4$  of  $SW_4$  of Section 1b, T. 13 S., R. 35 E., and the  $W_2$  of Section 16, T. 1h S., R. 35 E., M.D.M., without advertising, to the City of Los Angeles at a cash price of \$2200.00, subject to all statutory reservations, including minerals.

3h. (Sale of Vacant Federal Land, Obtained through Use of Base, Scrip Application No. \*CO\*, Sacramento Land District, Mendecino County - Division of Forestry - Sac. W.O. 203) The Commission was inforzed that a request has been received from the Division of Forestry of Sacramento, California, to select in behalf of the Division of Forestry the SW of NE of Section h, T. 17 N., R. 17 W., M.D.M., containing hO acres in Mendocine County. This land may be obtained by the State from the Federal Government through use of base. The Division of Forestry is willing to pay \$5.00 per acre or the appraised price, whichever is greater.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the filing for this land with the Federal Government, and upon the approval of the selection the sale of the SWL of NEL of Section 4, T. 17 N., R. 17 W., M.D.M., to the Division of Forestry at a cash price to be set by the Commission after appraisal report, subject to all statutory reservations including minerals.

35. (Authority to Execute Contracts - S.D. Accounting) The Commission was informed that by action at its meeting held April 11, 1948, the State Lands Commission granted the Executive Officer authority to execute contracts for the performance of necessary services in connection with the State Lands Division's
