BERRY A PERMIT TO OCCUPY A SMALL AREA OF SUBMERGED LANDS IN LAKE TAHOE AT HOMEWOOD, PLACER COUNTY, FOR THE CONSTRUCTION, MAINTENANCE AND USE OF A RECREATIONAL PIER, FOR A PERIOD OF TWO YEARS, AT A FRE OF \$20, NO BOND BEING REQUIRED.

Research is under way toward determination of the extent of State ownership of the lands beneath the waters of Lake Tahoe and lakeward of the meander line as surveyed to the U. S. General Land Office. A field survey of the shores of the lak. As started in 1950, but due to the high water level in 1951 cannot be completed before 1952.
