

4. (APPLICATION FOR RIGHT-OF-WAY EASEMENT, MALLARD SLOUGH, SANTA CLARA COUNTY, LESLIE SALT CO. - W.O. 1246, P.R.C. 721.1.) Leslie Salt Co. has applied for a right-of-way easement across Mallard Slough near Alviso for the purpose of installing pipe lines transporting brine. Filing fee and expense deposit have been paid.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO LESLIE SALT CO. A RIGHT-OF-WAY EASEMENT, 260 FEET IN LENGTH AND 100 FEET IN WIDTH, ACROSS MALLARD SLOUGH IN SANTA CLARA COUNTY, FOR THE INSTALLATION, MAINTENANCE AND USE OF PIPE LINES, EASEMENT TO BE FOR 49 YEARS, AT A RENTAL, PAID IN ADVANCE, OF \$50, THE MINIMUM RENTAL, NO BOND BEING REQUIRED.

5. (APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR AN OUTFALL SEWER, COUNTY SANITATION DISTRICTS OF ORANGE COUNTY - W.O. 1259, P.R.C. 722.6.) The County Sanitation Districts of Orange County have requested a right-of-way easement, adjacent to an existing easement, for an outfall sewer extending 7000 feet into the Pacific Ocean near the mouth of the Santa Ana River. No fee or rental is required from a political subdivision of the State.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE A RIGHT-OF-WAY EASEMENT TO THE COUNTY SANITATION DISTRICTS OF ORANGE COUNTY, 100 FEET IN WIDTH AND 7000 FEET IN LENGTH, EXTENDING INTO THE PACIFIC OCEAN, FOR THE CONSTRUCTION, MAINTENANCE AND USE OF AN OUTFALL SEWER. FOR SUCH PERIOD OF TIME AS THE RIGHT OF WAY IS USED FOR THE PURPOSE INTENDED, AT A CONSIDERATION OF NO FEE AND NO RENTAL.

6. (ASSIGNMENT OF EASEMENT P.R.C. 206, H. WARD DAWSON TO R. W. HANNA, MARIN COUNTY - W.O. 1225.) Application has been received from R. W. Hanna for assignment of Easement P.R.C. 206 to him from H. Ward Dawson.

The easement was originally issued to the California Packing Corporation for a strip of land 100 feet in width adjacent to the shoreline boundaries of Marin Meadows Ranch for the maintenance of the levee protecting that Ranch from the waters of San Pablo Bay. The easement was later assigned to Mr. Dawson and has nine more years to run.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO APPROVE THE ASSIGNMENT OF EASEMENT P.R.C. 206 FROM H. WARD DAWSON TO R. W. HANNA UPON PAYMENT OF THE STATUTORY \$5 FILING FEE.

7. (ASSIGNMENT OF LEASE P.R.C. 1181, LOT 7, FISH CANYON, LOS ANGELES COUNTY, CARL E. AND JANE WILDE TO IRENE E. YUENGLING - W.O. 1251.) Mr. and Mrs. Wilde have requested that Lease P.R.C. 1181, covering Lot 7, Fish Canyon, be assigned to Mrs. Irene E. Yuengling. Expiration date of the lease is August 12, 1957. Filing fee has been paid.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO APPROVE THE ASSIGNMENT OF LEASE P.R.C. 1181, COVERING LOT 7, FISH CANYON, LOS ANGELES COUNTY, FROM CARL E. AND JANE WILDE TO IRENE E. YUENGLING.
