UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, THE MINUTES OF THE MEETING OF APRIL 18, 1952, WERE APPROVED AND CONFIRMED AS SUBMITTED, WITH THE EXCEPTION OF MINUTE ITEM 38, PAGE 1545, IN WHICH THE DATE MENTIONED OF THE MINUTE ITEM ON PAGE 1526 WAS CORRECTED FROM JANUARY 4, 1952, TO FEBRUARY 14, 1952.

2. UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS DECIDED TO DEFER SETTING A DATE FOR THE NEXT COMMISSION MEETING.

3. (APPLICATION FOR RIGHT-OF-WAY EASEMENT, COYOTE CREEK, SANTA CLARA AND ALAMEDA COUNTIES, LESLIE SALT CO. - W.O. 1245, P.R.C. 657.1.) Leslie Salt Co. has applied for a right-of-way easement across Coyote Creek for the purpose of installing pipe lines transporting brine. Filing fee and expense deposit have been paid.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO LESLIE SALT CO. A RIGHT-OF-WAY EASEMENT, 600 FEET IN LENGTH AND 100 FEET IN WIDTH, ACROSS COYOTE CREEK IN SANTA CLARA AND ALAMEDA COUNTIES, FOR THE INSTALLATION, MAINTENANCE AND USE OF PIPE LINES, EASEMENT TO BE FOR 49 YEARS, AT A RENTAL, PAID IN ADVANCE, OF 15 CENTS PER LINEAL FOOT, OR A TOTAL OF \$90, NO BOND BEING REQUIRED.
