UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE A RIGHT-OF-WAY EASEMENT APPROXI-MATELY 376 FEET IN LENGTH AND 30 FEET IN WIDTH ON AND ACROSS CERTAIN UNDER-WATER STREETS IN THE CITY OF SAUSALITO TO THE SAUSALITO-MARIN CITY SANITARY DISTRICT FOR THE CONSTRUCTION, MAINTENANCE, AND DSE OF A SEWER; PERIOD OF THE EASEMENT TO BE FOR SUCH TIME AS THE AREA IS USED FOR THE PURPOSE INTENDED, THE CONSIDERATION BEING THE SEMEFIT TO THE PUBLIC.

5. (APPLICATION FOR A RIGHT OF WAY ACROSS LAKE LANDS, INTO COUNTY, DIVISION OF HIGHWAYS - W.O. 411, P.R.C. 738.1.) The Division of Highways, Department of Public Works, has requested a right of way 400 feet in width and 2,542.75 feet in length across lake lands within the meander lines of Owens Lake, in the  $W_2$  of Section 26, T. 16 S., R. 36 E., M.D.M., Invo County, pursuant to Section 6210.3 (1st) of the Public Resources Code. The 400-foot width is desired to conform with the right of way across Federal land at each end of the right of way applied for.

The location of this right of way is on sovereign lands of the State in Owens Lake that are under the jurisdiction of the Commission and are valuable for access to the lake. This location is practically the only point left to the State for such access, as at nearly all other places the State in earlier years sold the shore of Owens Lake into private ownership. A highway at this location will make ready access to the lake. However, because of other duties of the Commission, the right of way should be limited to highway use only, with reservation to the State Lands Commission of the right to prospect for and extract minerals and to issue rights of way for other purposes that in no way affect the use of the 400-foot strip for highway purposes. The permit should include a reversion to the State Lands Commission of the right of way at such time as it is no longer used for highway purposes.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE A RIGHT-OF-WAY EASEMENT TO THE DIVISION OF HIGHWAYS AND TO APPROVE THE MAP SHOWING A RIGHT OF WAX LOO FEET IN WIDTH AND 2,542.75 FEET IN LENGTH ACROSS THOSE CERTAIN LAKE LANDS IN OWENS LAKE IN THE WY OF SECTION 26, T. 16 S., R. 36 E., M.D.M., INYO COUNTY, FOR STATE HIGHWAY PURPOSES, WITH RIGHT IN THE COMMISSION (1) TO USE THE RIGHT OF WAY FOR ACCESS TO GMENS LAKE, (2) TO ISSUE RIGHTS OF WAY FOR OTHER USES NOT INCOMPATIBLE WITH THE USE FOR HIGHWAY PURPOSES, (3) TO RETAIN AUTHOR-ITY TO PROSPECT FOR AND EXTRACT MINERALS, AND (4) OF REVERSION TO THE STATE LANDS COMMISSION WHENEVER THE RIGHT OF WAY IS NO LONGER USED FOR HIGHWAY PURPOSES.

6. (APPLICATION FOR RIGHT-OF-MAY EASEMENT, KEN HOYCE, INC., ROCKAWAY BEACH, SAN MATEO COUNTY - W.O. 1276, P.R.C. 739.6.) On August 19, 1947, a rightof-way easement for a pipe line 70 feet in length, for procurement of sea water, was issued to Ken Royce for a period of one year, with right of renewal for fourteen periods of one year each at such reasonable terms and conditions as the State might impose. Annual rental under terms of the agreement amounted to \$41.40. Performance bond of \$1000 was furnished. This agreement terminated on August 18, 1952. Nollowing action of the Commission on October 24, 1951 (Item 20, Ninute Pages 1468-1473 inclusive), the rental schedule covering easements was revised from \$40 plus two cents per linea? foot annually to 0.6 cent per lineal foot annually or 15 cents per linea? foot for a period not to exceed forty-nine years, with a minimum total

rental of \$50. Under the revised schedule, a right-of-way easement 70 feet in length calls for the minimum of \$50 for any period of time to forty-nine years. In accordance with this revised schedule, Ken Royce, Inc. has requested a new easement agreement for a period not to exceed forty-nine years, at a rental, paid in advance, of \$50, in lieu of the present easement, P.R.C. 329.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE A NEW EASEMENT TO MEN ROICE, INC. FOR A RIGHT OF WAY 50 FEET IN WIDTH AND 70 FEET IN LENGTH ACROSS TIDE AND SUBMERGED LANDS AT ROCKAWAY BEACH, SAN MATEO COUNTY, FOR NOT MORE THAN FORTY-NINE YEARS, SUBJECT TO PAYMENT OF FILING FEE OF \$5, RENTAL OF \$50 FOR THE FULL PERIOD HAVING BEEN RECEIVED; NO BOND TO BE REQUIRED BECAUSE OF THE SMALL VALUE OF THE PIPE LINE WITHIN THE EASEMENT AREA.

(APPLICATION FOR RIGHT-OF-WAY EASEMENT, PETALUMA CREEK, SONOMA AND MARIN 7. COUNTIES, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 1059, P.R.C. 740.1.) Pacific Gas and Electric Company has applied for a right-of-way easement 100 feet in width and approximately 2900 feet in length across Petaluma Creek in Sonome and Marin Counties, approximately three-eighths of a mile easterly of the North Western Pacific Railroad Company's bridge at Black Point, for the construction, maintenance, replacement, and use of overhead electric transmission lines. It is requested that the easement applied for run for a period of forty-nine years at the established rental rate of 15 cents per lineal foot, or a total rental of \$135 for the full forty-nine year period. Pacific Gas and Electric Company was notified on February 8, 1951, of their occupancy of State lands. Value of the State lands occupied is estimated to be not in excess of \$50 per acre for the use intended. Performance bond in the amount of \$5000, to be covered by the \$50,000 blanket bond posted in 1944, is considered adequate to cover cost of removal of two towers within the easement area. Filing fee and expense deposit have been paid.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A RIGHT-OF-WAY EASEMENT LOO FEET IN WIDTH AND APPROXIMATELY 2900 FEET IN LENGTH ACROSS PETALUMA CREEK IN SONOMA AND MARIN COUNTIES, APPROXI-MATELY THREE-EIGHTHS OF A MILE EASTERLY OF THE NORTH WESTERN PACIFIC RAIL-ROAD COMPANY'S BRIDGE AT BLACK POINT, FOR THE CONSTRUCTION, MAINTENANCE, REPLACEMENT, AND USE OF ELECTRIC TRANSMISSION LINES FOR A HERIOD NOT TO EXCEED FORTY-NINE YEARS, EFFECTIVE DATE TO BE FEBRUARY 8, 1951, AT A TOTAL RENTAL, PAID IN ADVANCE, OF \$135, PERFORMANCE BOND IN THE AMOUNT OF \$5000 TO BE COVERED BY THE \$50,000 BLANKET BOND FURNISHED IN 1944.

8. (APPLICATION FOR RIGHT-OF-WAY EASEMENT, FACHECO CREEK, CONTRA COSTA COUNTY, PACIFIC GAS AND ELECTRIC COMPANY - W.C. 1295, P.R.C. 741.1.) Pacific Gas and Electric Company has applied for a right-of-way easement 100 feet in width and 100 feet in length across Pacheco Creek, Contra Costa County, for the suspension, maintenance, replacement, and use of overhead wires transmitting electric My, for a period not exceeding forty-nine years. Value of the State land - ssed is estimated to be not in excess of \$50 per acre for the use intended. Rental for the full period of the lease will be the minimum of \$50. Performance bond is not required, no structures being on the State lands. Filing fee and expense deposit have been received.
