38. (APPLICATION FOR ASSIGN. FNT OF LEASE P.R.C. 542, L. A. AND CLAIR M. MCINTOSH, MAPA HIVER, MAPA COUNTY - W.O. 1302.) Mr. and Mrs. McIntosh have requested that Lease P.R.C. 542 covering certain tide and submerged lands in the Napa River, Napa County, be assigned to George E. Hurd and Fred Maler. Filing fee has been paid.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO APPROVE THE ASSIGNMENT OF LEASE P.R.C. 542 BY L. A. AND CLAIR M. MCINTOSH TO GEORGE E. HURD AND FRED MILLER. MULLER.

39. (APPLICATION FOR PERMIT TO DREDGE, OLEUM, CONTRA COSTA COUNTY, UNION OIL COMPANY OF CALIFORNIA - W.O. 1306, P.R.C. 759.1.) Union Oil Company of California has applied for a permit to dredge an estimated 150,000 cubic yards of silt recently deposited by stream action adjacent to that Company's wharf at Oleum, Contra Costa County, and deposit the spoils on the Union Oil Company of California's property or alternatively in deep water in Carquines Straits. The dredging is necessary to maintain sufficient depth of water for docking oil tankers, and will be for the benefit of navigation. No permit fee is required. Filing fee has been paid.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO UNION OIL COMPANY OF CALIFORNIA A FERSIT TO DREDGE AN ESTIMATED 150,000 CUBIC YARDS OF SILT FROM SHCALED AREAS ADJACENT TO THAT COMPANY'S WHARF AT OLEUM, CONTRA COSTA COUNTY, THE CONSIDERA-TICN ESING THE EENEFIT TO NAVIGATION, DREDGED MATERIAL TO BE DEPOSITED ON THE UNION OIL COMPANY OF CALIFORNIA'S PROPERTY OR ALTERNATIVELY IN DEEP WATER IN CAEQUINEZ STRAITS.

10. (DREDGING IN SOUTH SAN FRANCISCO BAY AND GUADALUPE RIVER, SANTA CLARA COENTY, DISTRICT PUBLIC WORKS OFFICE, TWELFTH NAVAL DISTRICT - W.O. 1307, P.R.C. 760.1.) An application has been received from the District Public Works Office, Twelfth Naval District, San Bruno, California, for the dredging of a channel in South San Francisco Bay and the Guadalupe River, and for the construction of a wharf in the latter for the service of fuel barges and other vessels appertaining to the operation of the U.S. Naval Air Station at Moffett Field. No filing fees or rentals are required or appear to be appropriate in this case, inasmuch as the project is in the interest of the public and is undertaken by the United States Government.

UTC MOTION DULY MADE AND UNANTHOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE U.S. DEPARTMENT IF NAVI FOR THE DREDGING AND MAINTENANCE OF A NAVIGABLE CHANNEL IN SOUTH IN FRANCISCO BAY AND THE LOWER END OF THE GUADALUPE RIVER, SANTA CLARA INTI, AND FOR THE CONSTRUCTION AND MAINTENANCE OF A MHARF IN THE RIVER, NO FILS NOR RENTAL TO BE REQUIRED IN VIEW OF THE PUBLIC INTEREST SERVED.

1. (GEOPHYSICAL EXPLORATION, GREY LODGE REFUGE, BUTTE COUNTY - W.O. 1125, F.R.C. 761.1.) The Department of Fish and Game has proposed the transfer of the Grey Lodge Refuge area in Butte County, containing 2,542 acres, to the that Lands Commission in order that the Commission can offer the lands for the Lands Commission in order that the Commission can offer the lands for tas lease. Several prospective bidders have made application to the the Conduct geophysical operations on the subject lands prior to the transfer September

of control and possession and offering of the lands for lesse. Pursuant to such applications, the Department of Fish and Game has requested that the matter of the issuance of any geophysical exploration permit be handled by the State Lands Commission as though the transfer of control and possession of the Grey Lodge Refuge area had already been a ffected. A conference is being scheduled between all applicants interested in participation in a joint geophysical exploration permit to be issued for exploration operations on the subject refuge area and the Division of State Lands, to review the conditions of a permit to be issued and determine the final procedures for issuance of the permit to the participating group. Such method of exploration was adopted as a policy by the State Fish and Game Commission on September 28, 1951. The form of permit proposed to be issued incorporates those applicable general conditions as contained in the permits authorized by the Commission for exploration on tide and submerged lands, and special operating conditions required by the Department of Fish and Game to minimize surface interference in the refuge area. It also contains a special condition that a copy of all data received by the permittee from the exploration contractor conducting the geophysical operations be filed with the State Lands Commission as confidential information. The purpose of this condition is to provide information necessary in future evaluation of any gas lease bids.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO EXECUTE AND ISSUE ONE GEOPHYSICAL EXPLORATION PERMIT, IN THE FORM WHICH FOLLOWS, TO THE GROUP OF PARTICIPANTS DETERMINED FROM A PUBLIC NOTICE DISTRIBUTED AUGUST 4, 1952, FOR THE CONDUCT OF GEOPHISICAL EXPLORATION OPERATIONS ON THE LANDS OF THE GREY LODGE REFUGE, BUTTE COUNTY, IN T. 17 N., R. 1 E., M.D.M.

FERMIT FOR THE CONDUCT OF GEOPHYSICAL EXPLORATION OPERATIONS ON LANDS OF T.E STATE OF CALIFORNIA

Permission is granted hereby to the for the conduct of seismograph geophysical exploration work between and inclusive, on those lands under the jurisdiction of the Department of Fish and Game, described as follows:

The conduct of any operations under this permit is subject to the following specific conditions:

1. No explosives shall be discharged under any circumstances except in accordance with the specific terms of this permit.

2. Operations shall be suspended on order of the Resident Manager of Grey Lodge Refuge or the Division of State Lands inspector whenever and for

such time as may be required to establish that the conditions of this permit are being complied with.

3. A copy of the schedule of operations conducted shall be furnished to the Division of State Lands, 302 State Building, Los Angeles 12, California, on the 15th and last day of each month of operations. Such schedule shall be complete in detail as to location, number, size and type of placement of shots fired.

4. All shots shall be placed in drilled shot-holes not less than 20 fret below the surface of the ground. Upon completion of shooting, all shotholes shall be filled so as to restore the surface to substantially the original condition prior to shooting.

5. No shots will be permitted in excess of a standard charge of 20 pounds of 60% dynamite or equivalent.

6. The permittee agrees to indemnify the State against any and all losses, damages, claims, demands or actions caused by, arising out of, or connected with the operations of the permittee hereunder.

7. Geophysical explorations shall be completed prior to September 30, 1952.

8. The maximum number of shots permitted shall not exceed 4 per section, unless permission to do so is granted by the Resident Manager in charge of Grey Lodge Refuge. Placement of shots shall be in fields adjacent to roads, excepting, where conditions make it impossible for equipment to work in fields. In these exceptions shots may be placed on roadways, provided, however, holes will be drilled along edge of roadways or shoulders. No shots will be permitted within 500 feet of any building or water well.

9. No conditions will be imposed as to amount of equipment or crews that will be allowed to operate. However, at no time will equipment used be permitted to block roadways or disrupt the work and maintenance of Grey Lodge Refuge. Any damage to roadways or other facilities of Grey Lodge Refuge will be repaired by permittee.

10. A copy of all data received by the applicant from the contractor conducting the geophysical exploration shall be filed with the State Lands Commission as confidential information. In the event that the exploration operations are conducted by crews in the employ of the permittee, a copy of profile and structure map as furnished normally by a geophysical exploration contractor shall be filed with the State Lands Commission as confidential information.

This permit is revocable at any time by the State Lands Commission.
