23. (APPLICATION FOR PERMIT TO CONSTRUCT A PIER, LAKE TAHOE, EL DORADO COUNTY, O. R. MARTIN AND R. PLIMPTON - W.O. 1305, P.R.C. 770.1.) Messrs. Martin and Plimpton have applied for a permit to construct a recreational pier in Lake Tahoe. Due to the high-water situation at Lake Tahoe, the Staff has been unable to complete its survey and investigation of the shore of the lake and of the many purprestures on State lands. It is therefore considered advisable to issue permits for a period of no more than two years, pending completion of the investigation. Filing and permit fees have been paid.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO O. R. MARTIN AND R. PLIMPTON A PERMIT FOR THE CONSTRUCTION, MAINTENANCE AND USE OF A RECREATIONAL PIER APPROXIMATELY 0.26 MILES SOUTH OF THE MOUTH OF CASCADE CREEK, LAKE TAHOE, FOR A PERIOD OF TWO YEARS, PERMIT FEE TO BE \$20, TERMS OF THE PERMIT TO BE SUBJECT TO REVISION AT THE END OF THE TWO-YEAR PERIOD.

24. (APPLICATION FOR A PERMIT TO INSTALL A SEWER OUTFALL, SACRAMENTO RIVER, SACRAMENTO COUNTY, CITY OF SACRAMENTO AS APPLICANT - W.O. 1313, P.R.C. 771.1.) The City of Sacramento has applied for a permit to install a sewer outfall in the Sacramento River at Sacramento.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO THE CITY OF SACRAMENTO A PERMIT TO INSTALL A SEWER OUTFALL IN THE SACRAMENTO RIVER AT SACRAMENTO FOR SUCH PERIOD OF TIME AS THE PROPOSED INSTALLATIONS ARE MAINTAINED AND USED, THE CONSIDERATION BEING THAT THE PROJECT IS IN THE PUBLIC INTEREST.

25. (APPLICATION FOR RENEWAL OF LEASE, LOT 44, FISH CANYON, LOS ANGELES COUNTY, GILBERT R. FRICK - W.O. 1312, P.R.C. 1257.2.) Due to the anticipated exchange of Section 16, T. 1 N., R. 10 W., S.B.M., in which Fish Canyon is located, for Federal land in other parts of the State, it is considered inadvisable to issue the requested lease for more than one year, with right of renewal for an additional ten years, the ten-year renewal being for the purpose of protecting the State's lessees after the exchange.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO GILBERT R. FRICK A NEW LEASE COVERING LOT 44, FISH CANYON, LOS ANGELES COUNTY, REPLACING LEASE P.R.C. 1046 WHICH EXPIRED AUGUST 28, 1952, FOR A PERIOD OF ONE YEAR AT AN ANNUAL RENTAL OF \$30, WITH RIGHT OF RENEWAL FOR AN ADDITIONAL PERIOD OF TEN YEARS AT SUCH TERMS AND CONDITIONS AS MAY BE DETERMINED PRIOR TO RENEWAL.

26. (REQUEST FOR TERMINATION OF LEASE P.R.C. 651, CONTRA COSTA COUNTY, JOHN H. WOLF.) Mr. John H. Wolf was issued a commercial lease, effective September 20, 1951, covering a small area in Piper Slough, Contra Costa County, for the construction, maintenance and use of a floating dock. Mr. Wolf now informs us that the adjacent upland has been sold, that no structures were built on the leased area, and that termination of the lease is requested. The first and last years' rentals have been paid.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO TERMINATE LEASE P.R.C. 651 ISSUED TO JOHN H. WOLF, TERMINATION TO BE EFFECTIVE SEPTEMBER 20, 1952, WITH NO REFUND OF ANY RENTAL PAID IN ADVANCE.
