6. (CORRECTIONS TO MINUTE ITEMS.)

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED CORRECTING THE FOLLOWING MINUTE ITEMS:

- (1) ITEM 18, MINUTE PAGE 1670, OF MINUTES OF DECEMBER 5, 1952; AND ITEM 3, MINUTE PAGE 1625, OF MINUTES OF SEPTEMBER 30, 1952 ADOLPH G. SUTRO CHANGED NO. P.R.C. 742.1 TO P.R.C. 742.6.
- (2) ITEM 4, MINUTE PAGE 1662, OF MINUTES OF DECEMBER 5, 1952 A. J. WHEELER CHANGED NO. P.R.C. ??1.1 TO P.R.C. ???.1.
- (SUBMARINE GEOPHYSICAL EXPLORATION, SANTA BARBARA COUNTY, HUMBLE OIL AND REFINING COMPANY - W.O. 1327.) The Humble Oil and Refining Company has made application for authorization of the conduct of submarine geophysical exploration work on those tide and submerged lands under the jurisdiction of the State Lands Commission lying westerly of the easterly limits of the City of Santa Barbara, as extended, easterly of the westerly limits of the City of Santa Barbara, as extended, and southerly of an east-west line drawn two miles offshore from the old Santa Barbara lighthouse, during the period December 1, 1952, to March 1, 1953, inclusive. Seismic shots would be limited to the submerged land areas more than six miles from shore and to three lines of shots two, four and six miles from shore, and to two north-south lines extending two to six miles from shore, respectively. In addition, the seismograph work would be completed in not more than 20 working days at some time during the permit period. Deferment of consideration of this application was requested by Humble Oil and Refining Company at the December 5, 1952, meeting, but the Commission's consideration is now desired.

The Department of Fish and Gamelas granted a concurrent permit for the use of explosives in connection with the proposed operations. The Board of Supervisors of the County of Santa Barbara, the District Attorney of the County of Santa Barbara, and the Hayor of the City of Santa Barbara have been informed that this application is to be considered. The District Attorney of Santa Barbara County has reported that while the County is withdrawing opposition to the granting of the subject permit, such withdrawal is based on the assumption that either the Legislature or the State Lands Commission will impose restrictions on any future offshore drilling that would be satisfactory to the County. The City of Santa Barbara has filed a letter protest against the permit application of the Humble Oil and Refining Company, and the Mayor of Santa Barbara has been authorized to appear and reiterate the protest of the City Council. In addition, numerous letters of objection have been submitted by individuals in connection with the subject application, the majority of which object to offshore drilling only, and do not object to geophysical exploration operations.

Mayor Norris Montgomery of the City of Santa Barbara, and Editor Frank A. Clarvoe of the Santa Barbara News-Press appeared before the Commission to protest issuance of a geophysical exploration permit.

District Attorney Vern B. Thomas of Santa Barbara County appeared before the Commission to present a file of letters in protest against oil drilling. He
