19. (APPLICATION FOR PERMIT TO INSTALL A WATER QUALITY RECORDER STATION, SACRAMENTO RIVER, SACRAMENTO COUNTY, U. S. BUREAU OF RECLAMATION - W.O. 1399, P.R.C. 787.1.) Application has been received from the U.S. Bureau of Reclamation for a permit to install a small platform, to be located approximately 30 feet waterward from the mean high-water line, in the Sacramento River, Sacramento County, to be used as a water quality recorder station.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

The Executive Officer is authorized to issue to the U. S. Bureau of Reclamation a permit to install a water quality recorder station in the Sacramento River, Sacramento County, between the towns of Courtland and Hood.

20. (EXTENSION OF TIME, NONRESTRICTIVE USE OF SCHOOL LANDS IN SALTON SEA, IMPERIAL AND RIVERSIDE COUNTIES, ELEVENTH NAVAL DISTRICT - P.R.C. 597.) Application has been received from the Eleventh Naval District for a second extension of Permit P.R.C. 597, which was authorized on February 28, 1951, for a period of one year, and extended by authorization granted on February 14, 1952.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

The Executive Officer is authorized to issue to the U. S. Navy an extension of one year of Permit P.R.C. 597, said permit being for the nonrestrictive use by the Navy of the NE1 of the NW1 of Section 16, T. 8 S., R. 10 E., Riverside County; the Ng of the SW2 of Section 16 and all of Section 36, T. 9 S., R. 11 E., Imperial County, all S.B.M., comprising 760 acres of State school lands beneath the waters of the Salton Sea, such permit to be for the purpose of occasional seaplane landing training operations during periods of instrument weather in the San Diego area, at me fee and no rental, the consideration being the public interest; permit to be effective February 28, 1953.

21. (APPLICATION TO FURCHASE MINERAL RESERVATION, IOS ANGELES COUNTY, ELBERT, LTD. - W.O. 1340, Geo.) An application has been made by Elbert, Ltd. to purchase the mineral reservations of the State of California in the property described as lots 193 and 207 of Hammerton Tract, County of los Angeles, as per Map recorded in Book 40, Pages 2 to 4 of Maps, in the Office of the County Recorder. The subject property was acquired by the State in escheat proceedings in the estate of Dora McNulty, Probate No. 146058, Los Angeles County. Elbert, Ltd. is the successor in interest to the title to the land by reason of a sale by the State Controller on September 25, 1946, which sale reserved all minerals in the land to the State. The application is made pursuant to Section 6406 of the Public Resources Cods, which authorizes the Commission to sell such reservations made heretofore. The statutory \$5 application filling fee has been paid.
