16. (SALE OF VACANT FEDERAL LAND, OBTAINED THROUGH USE OF BASE, SCRIP APPLICATION NO. 4840, SACRAMENTO LAND DISTRICT, SONOMA COUNTY, WILLIE DOMENICHELLI - S.W.O. 5394.) The only value is for hunting and watershed protection.

The State's application to select the land on behalf of the State applicant, Willie Domenichelli, has been accepted by the Bureau of Land Management, subject to future approval and listing.
