20. (SUBMARINE GEOPHYSICAL EXPLORATION, VENTURA COUNTY, UNION OIL COMPANY OF CALIFORNIA - W.O. 1554, P.R.C. 874.1.) The Union Oil Company of California has made application for authorization to conduct submarine geophysical exploration operations on those tide and submerged lands under the jurisdiction of the State Lands Commission lying in the area offshore in the County of Vertura. The Board of Supervisors of Ventura County were informed that this application was to be considered. The statutory filing fee has been paid by the applicant.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

The Executive Officer is authorized to issue a permit, confirming to all operating conditions established by the Commission, to the Union Oil Company of California for the conduct of submarine geophysical exploration operations on those tide and submerged lands under the jurisdiction of the State Lands Commission lying offshore in the County of Ventura, for the period December 1, 1953, to February 28, 1954, inclusive, the permittee to reimburse the Division of State Lands for all of its inspection costs. The permit is to be effective only as long as a concurrent permit by the Fish and Game Commission is in effect for the same operating area.

The Executive Officer is further directed to prepare a recommendation for future action by the Commission with respect to a change of operating limitations in submarine geophysical exploration permits as affecting kelp.

21. (SUBMARINE GEOPHYSICAL EXPLORATION, SAN IUIS OBISPO, LOS ANGELES, ORANGE AND SAN DIEGO COUNTIES, UNION OIL COMPANY OF CALIFORNIA - W.O. 1561, P.R.C. 875.1.) The Union Oil Company of California has made application for authorization to conduct submarine geophysical exploration operations on those tide and submerged lands under the jurisdiction of the State Lands Commission lying southerly from a line drawn due West from Point Estato and northerly of the westerly limits of Santa Barbara County, and southerly and easterly from the westerly limits of Los Angeles County to the projection seaward of the California-Mexico Border. The Boards of Supervisors of San Luis Obispo, Los Angeles, Orange and San Diego Counties were informed that this application was to be considered. The statutory filing fee has been paid by the applicant.
