22. (SUBMARINE GEOPHYSICAL EXPLORATION, SANTA BARBARA COUNTY, UNION OIL GOAPANY OF CALIFORNIA - W.O. 1560, P.R.C. 876.1.) The Union Oil Company of Galifornia has made applitation for authorization to conduct submarine geophysical exploration operations on those tide and submerged lands under the jurisdiction of the State Lands Commission lying in the area offshore in the County of Santa Barbara. The Board of Supervisors and the District Attorney of Santa Barbara County were informed that this application was to be considered and reported that there was no objection to a permit on the basis recommended. Five letters of protest were received from residents of the Hope Ranch area protesting further exploration because it might lead to oil and gas development. The statutory filing fee has been paid by the applicant. The permit operating conditions to be specified are those accepted heretofore by the Board of Supervisors, the District Attorney and the City of Santa Barbara for all Santa Barbara offshore operations.

## UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

The Executive Officer is authorized to issue a permit, conforming to all operating conditions established by the Commission, to the Union Oil Company of California for the conduct of submarine geophysical exploration operations on those tide and submerged lands under the jurisdiction of the State Lands Commission lying offshore in the County of Santa Barbara, for the period December 1, 1953, to February 28, 1954, inclusive, the permittee to reimburse the Division of State Lands for all of its inspection costs. The permit is to be effective only as long as a concurrent permit by the Fish and Game Commission is in effect for the same operating area.

23. (APPLICATION FOR EXTENSION OF SUBMARINE GEOPHYSICAL EXPLORATION FERMIT, LOS ANGELES, ORANGE AND SAN DIEGO COUNTIES, RICHFIELD OIL CORPORATION -P.R.C. 853.1.) The Richfield Oil Corporation has made application for extension of the term of Submarine Geophysical Exploration Permit P.R.C. 853.1, authorized for operation offshore in Los Angeles, Orange and San Diego Counties, issued October 27, 1953 (Minute Item 15, Page 1890), to permit completion of exploration operations which are in progress currently. Permit P.R.C. 853.1 was issued for the period October 27, 1953, to December 14, 1953, inclusive. The time extension requested is for the period December 15, 1953, to March 1, 1954, inclusive, for the area between Pt. Dume and the California-Mexico Border, and December 15, 1953, to March 15, 1954, for the area between the northerly line of Los Angeles County and Pt. Dume. The Boards of Supervisors of the Counties of Los Angeles, Orange and San Diego were informed that this extension was to be considered.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

The Executive Officer is authorized to issue an extension of Submarine Geophysical Exploration Permit P.R.G. 853-1 in conformance with all operating conditions established by the Commission, to the Richfield Oil Corporation for the conduct of submarine geophysical exploration operations on those tide and subterged lands under the jurisdiction of the State Lands Commission lying between Pt. Dume, Los Angeles County, and the projection seaward of the California-Mexico Border, for the period December 15, 1953, to March 1, 1954,

inclusive, and December 15, 1953, to March 15, 1954, inclusive, for the area between the northerly line of Los Angeles County and Pt. Dume. All other terms and conditions of the permit are to remain unchanged. The permit extension is to be effective only as long as a concurrent permit by the Fish and Game Commission is in effect for the same operating area.

24. (APPLICATION FOR A RIGHT-OF-WAY EASEMENT, SCHOOL LANDS, LASSEN COUNTY, BUILDERS CORPORATION OF AMERICA - W.O. 1558, P.R.C. 1325.2.) Builders Corporation of America has applied for a right-of-way easement 100 feet in width and approximately 3,987 feet in total length across school lands in Lassen County for the construction, maintenance and use of an outfall sewer line to service a Wherry Housing Project. The proposed easement lies chiefly within the Sierra Ordnance Depot, which is under Lease P.R.C. 514-2, issued to the United States for military purposes, and partially within Essement P.R.C. 1304.2, issued to Herlong-Sierra Homes, Inc. for an access road to said heasing project. Rental in full at the rate of 15 cents per lineal foot for a period not to exceed 49 years will be \$598.05. For the purpose of financing this project, the applicant is required to have a lease or easement for a minimum term of 75 years. Since the State Lands Commission lacks the power to issue an easement in excess of 49 years, the applicant has requested that the 49-year period become effective upon the termination or expiration of Lease P.R.C. 514.2, which expires June 30, 1985, if all the rights of renewal are exercised by the United States, thereby permitting him to comply with his requirements. The Army and Herlong-Sierra Homes, Inc. have consented to the issuance of this easement. No performance bond is required. Filing fee and expense deposit have been paid.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

The Executive Officer is authorized to issue to the Builders Corporation of America a right-of-way easement 100 feet in width and approximately 3,987 feet in total length, lying chiefly within the Sierra Ordnance Depot on school lands, Lassen County, which is under Lease P.R.C. 514.2, issued to the United States for military purposes, and lying partially within the area encompassed by Easement P.R.C. 1504.2, issued to Herlong-Sierra Homes, Inc. for an access road, for the construction, maintenance and use of an outfail sewer line to service a Wherry Housing Project. Rental in full for a period not to exceed 49 years will be \$598.05, psyable in advance, no performance bond being required, said 49-year term to become effective upon the termination or expiration of Lease P.R.C. 514.2 (U.S. Lease No. DA-O4-203-ENG-144).

25. (APPLICATION FOR A RIGHT-OF-WAY EASEMENT, SCHOOL LANDS, LASSEN COUNTY, BUILDERS CORPORATION OF AMERICA - W.O. 1559, P.R.C. 1326.2.) Builders Corporation of America has applied for a right-of-way easement 25 feet in width and 1,070 feet in length across school lands in Lassen County for the construction, maintenance and use of a water line to service a Wherry Housing Project. The proposed easement lies chiefly within the Sierra Ordnance Depot, which is under Lease P.R.C. 514.2, issued to the United States for military purposes, and partially within Easement P.R.C. 1304.2, issued to Herlong-Sierra Homes, Inc. for an access road to said housing project. Rental in full at the rate of 15 cents per lineal foot for a period not to excees 19 years will be \$160.0.
