25. (APPLICATION FOR EXTENSION OF SUBMARINE GEOPHYSICAL EXPLORATION PERMIT, VENTURA COUNTY, UNION OIL COMPANY OF CALIFORNIA - P.R.C. 874.1.) The Union Oil Company of California has made application for extension of the term of Submarine Geophysical Exploration Permit P.R.C. 874.1, authorized for operation offshore in Ventura County, to permit completion of the exploration program which is in progress currently. P.R.C. 874.1 was issued for the period December 1, 1953, to February 28, 1954, inclusive. The time extension requested is for the period March 1, 1954, to June 29, 1954, inclusive. The Board of Supervisors of the County of Ventura were informed that this extension was to be considered.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

The Executive Officer is authorized to issue an extension of Submarine Geophysical Exploration Permit P.R.C. 874.1, in conformance with all operating conditions established by the Commission, to the Union Oil Company of California for the conduct of submarine geophysical exploration operations on those tide and submerged lands under the jurisdiction of the State Lands Commission lying offshore in the County of Ventura, for the period March 1, 1954, to June 29, 1954, inclusive. All other terms and conditions of the exploration permit are to remain unchanged and the extension is to be effective only as long as a concurrent permit by the Fish and Game Commission is in effect for the same operating area.

26. (APPLICATION FOR EXTENSION OF SUBMARINE GEOPHYSICAL EXPLORATION PERMIT, SAN LUIS OBISPO, LOS ANGELES, ORANGE AND SAN DIEGO COUNTIES, UNION OIL COMPANY OF CALIFORNIA - P.R.C. 875.1.) The Union Oil Company of California has made application for extension of the term of Submarine Geophysical Exploration Permit P.R.C. 875.1, authorized for operation offshore in the area between San Luis Obispo County and the California-Mexico Border, with the exception of Ventura and Santa Barbara Counties, to permit completion of the exploration program which is in progress currently. Permit P.R.C. 875.1 was issued for the period December 1, 1953, to February 28, 1954, inclusive. The time extension requested is for the period March 1, 1954, to June 29, 1954, inclusive. The Boards of Supervisors of the Counties of San Luis Obispo, Los Angeles, Orange and San Diego were informed that this extension was to be considered.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

The Executive Officer is authorized to issue an extension of Submarine Geophysical Exploration Permit P.R.C. 875.1, in conformance with all operating conditions established by the Commission, to the Union Oil Company of California for the conduct of submarine geophysical exploration operations on those tide and submerged lands under the jurisdiction of the State Lands Commission lying southerly from a line drawn due West from Point Estero and northerly of the westerly limits of Santa Barbara County, and southerly and easterly from the westerly limits of Los Angeles County to the projection seaward of the California-Mexico Border, for the period March 1, 1954, to June 29, 1954, inclusive. All other terms and conditions of the exploration permit are to remain unchanged, and the extension is to be effective only as long as a concurrent permit by the Fish and Game Commission is in effect for the same operating area.
