18. (APPLICATION FOR EXTENSION OF SUBMARINE GEOPHYSICAL EXPLORATION PERMIT, LOS ANGELES COUNTY, WESTERN GULF OIL COMPANY - P.R.C. 821.1(C).) The Western Gulf Oil Company has made application for extension of Submarine Geophysical Exploration Permit P.R.C. 821.1(C), authorized for operations offshore in Los Angeles County. Permit P.R.C. 821.1(C) was issued originally November 1, 1953, and on February 9, 1954, was extended to terminate May 1, 1954. The County of Los Angeles reported that there was no objection to such extension. The time extension now requested is for a 90-day perhod from May 1, 1954. The Board of Supervisors of the County of Los Angeles were informed that this extension was to be considered.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

19. (APPLICATION FOR EXTENSION OF SUBMARINE GEOPHYSICAL EXPLORATION PERMIT, SANTA BARBARA COUNTY, SIGNAL OIL AND GAS COMPANY - W.O. 1703, P.R.C. 964.1.) The Signal Oil and Gas Company has made application for extension of Submarine Geophysical Exploration Permit P.R.C. 964.1, authorized for operations offshore in Santa Barbara County. Permit P.R.C. 964.1 was issued March 26, 1954, to

20. (AUTHORIZATION FOR EXTRACTION OF SAND AND GRAVEL, SAN FRANCISCO BAY, DIVISION OF HIGHWAYS - W. O. 1819, P.R.C. 1376.9.) An application has been received from the Division of Highways pursuant to Section 101.5 of the Streets and Highways Code for an authorization to remove not to exceed 700,000 cubic yards of material from the Fort Knox and Presidio Shoal areas of San Francisco Bay for use in construction of a revision of the San Francisco-Oakland Bay Bridge toll plaza.

Authorization has been granted by the Commission heretofore (Minute Item 6, page 1881, meeting of October 27, 1953) for the removal by the Division of Highways of a maximum amount of 2,200,000 cubic yards of material from the same area for which application has now been made. No material was removed under this prior authorization. Removal of sand and gravel from the same area is also authorized under nonexclusive material extraction Lease P.R.C. 709.1, issued February 14, 1952, to Construction Aggregates Corporation. No materials have been extracted under this lease to date.

Section 101.5 of the Etreets and Highways Code provides that the Department of Public Works may file for record with the Division of State Lands such maps as are necessary to furnish an accurate description of the lands which are needed as a source of materials for the construction, maintenance or improvement of any highway, and that upon approval of such maps by the Division of State Lands, the lands described therein are reserved for such use by the Department of Public Works.
