9. (APPLICATION FOR APPROVAL OF REMOVAL OF PIER AND INSTALIATION OF FLOAT, TIDE AND SUBMERCED LAND, SANTA CATALINA ISLAND, LOS ANGELES COUNTY, SANTA CATALINA ISLAND COMPANY - P.R.C. 185.6.)
