1. UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, THE MINUTES OF THE MEETING OF THE STATE LANDS COMMISSION HELD IN SACRAMENTO ON DECEMBER 17, 1954, WERE CONFIRMED AS SUBMITTED.

3. (SALE OF VACANT FEDERAL LAND, OBTAINED THROUGH USE OF BASE, SCRIP APPLICATION NO. 4770, SACRAMENTO LAND DISTRICT, HUMBOLDT COUNTY, EVERETT MILTON COTTRELL - S.W.O. 5309.) The following report was presented to the Commission by the staff:

"At the meeting of the State Lands Commission held in Sacramento on March 26, 1954, the Commission approved the sale to Everett Milton Cottrell of Bridgeville, Humboldt County, California, of the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 5, T. 1 S., R. 5 E., H.M., containing 40 acres in Humboldt County. However, a typographical error occurred in the resolution passed by the Commission in that 'Section 4' should have been specified in lieu of 'Section 5'."
