IN EXCESS OF 500 FEET BELOW THE SURFACE OF THE OCEAN FLOOR IN TIDE AND SUB-MERGED LANDS LYING BETWEEN A LINE DRAWN DUE SOUTH FROM A POINT ON THE ORDINARY HIGH WATER MARK SIX MILES EASTERLY OF POINT DUME, LOS ANGELES COUNTY, AND A LINE DRAWN DUE SOUTH FROM DAMA POINT, ORANGE COUNTY. THE PERMITTEE IS TO REIMBURSE THE STATE LANDS COMMISSION FOR ALL OF ITS INSPECTION COSTS.

26. (GEOLOGICAL SURVEY PERMIT, SANTA BARBARA, VENTURA, LOS ANGELES AND ORANGE COUNTIES, WESTERN GULF OIL COMPANY - W. O. 2338, P.R.C. 1720.1.) The following report was presented to the Commission:

"An application has been received from Western Gulf Oil Company for permission to conduct geological exploration from mobile marine equipment. THE FERMITTEE IS TO REIMHURSE THE STATE LANDS COMMISSION FOR ALL OF ITS INSPECTION COSTS.

27. (SUBMARINE GEOPHYSICAL EXPLORATION, LOS ANGELES, VENTURA, SANTA BARBARA AND SAN LOIS OPISPO COUNTIES, THE TEXAS COMPANY - W. O. 2334, P.R.C. 1721.1.) The following report was presented to the Commission:

"The Texas Company has made application for authorization to conduct submarine geophysical exploration operations on those tide and submerged lands under the jurisdiction of the State Lands Commission as follows:

- 1. The offshore area lying between a line drawn due West from Point San Luis, San Luis Obispo County, and a line drawn due South from Point Conception, Santa Barbara County; and
- 2. The offshore area lying between a line drawn due South from Cosl Oil Point, Santa Barbara County, and a line drawn due South of a point six miles east of Point Dume, Los Angeles County."

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A FERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION ON OR BEFORE MAY 18, 1956, TO THE TEXAS COMPANY FOR THE CONDUCT OF GEOPHYSICAL EXPLORATION OPERATIONS ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION WITHIN THE FOLLOWING DESCRIBED OFFSHORE AREAS:

- 1. LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT SAN LUIS, SAN LUIS OBISPO COUNTY, AND A LINE DRAWN DUE SOUTH FROM POINT CONCEPTION, SANTA BARBARA COUNTY;
- 2. LYING BETWEEN A LINE DRAWN DUE SOUTH FROM COAL OIL POINT, SANTA BARBARA COUNTY, AND A LINE DRAWN DUE SOUTH FROM A POINT ON THE ORDINARY HIGH WATER MARK SIX MILES EASTERLY OF POINT DUME, LOS ANGELES COUNTY.

THE PERMIT IS TO BE FOR THE OPERATING PERIOD JULY 1, 1956 THROUGH AUGUST 31, 1956. THE PERMITTEE IS TO REIMBURSE THE STATE LANDS COMMISSION FOR ALL OF ITS INSPECTION COSTS. THE PERMIT IS TO BE EFFECTIVE ONLY AS LONG AS A CONCURRENT PERMIT BY THE FISH AND GAME COMMISSION IS IN EFFECT FOR THE SAME OPERATING AREA.

28. (SUBMARINE GEOPHYSICAL EXPLORATION, LOS ANGELES AND ORANGE COUNTIES, MONTEREY OIL COMPANY - W. O. 2336, P.R.C. 1722.1.) The following report was presented to the Commission:

"The Monterey Oil Company has made application for authorization to conduct submarine geophysical exploration operations on those tide and submerged lands under the jurisdiction of the State Land." Commission lying between a line drawn due South of a point six miles east of Point Dume, Los Angeles County, and a line drawn due South of Point Dana, Orange County. An operating permit has been requested for a 90-day period starting July 1, 1956. The statutory application filing fee has been paid by the applicant."

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT, CONFORMING TO ALL OFERATING CONDITIONS ESTABLISHED BY THE COMMISSION ON OR BEFORE MAY 18, 1956, TO THE MONTEREY OIL COMPANY FOR THE CONDUCT OF GEOPHYSICAL EXPLORATION OF THE OFFICE ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION LYING BETWEEN A LINE DRAWN DUE SOUTH FROM A FOINT ON THE ORDINARY HIGH WATER MARK SIX MILES EASTERLY OF POINT DUME, LOS ANGELES COUNTY, AND A LINE DRAWN DUE SOUTH FROM DANA POINT, ORANGE COUNTY. THE PERMIT IS TO BE FOR THE OPERATING PERIOD JULY 1, 1956 THROUGH SEPTEMBER 30, 1956. THE PERMITTEE IS TO REIMBURSE THE STATE LANDS COMMISSION FOR ALL OF ITS INSPECTION COSTS. THE PERMIT IS TO BE EXTECTIVE ONLY AS LONG AS A CONCURRENT PERMIT BY THE FISH AND GAME COMMISSION IS IN EFFECT FOR THE SAME OPERATING AREA.
