18. (WITHDRAWAL OF STATE LANDS FOR STATE DIVISION OF WATER RESOURCES, LAKE COUNTY - S.W.O. 6260.) The following report was presented to the Commission:

"A request has been received from the State Division of Water Resources, signed by Harvey O. Banks, State Engineer, for temporary withdrawal from sale of the W2 of SET of Section 19, SW1 of NW1 and NW1 of SW1 of Section 27, N2 of S2 of Section 28, E2 of NW1, W2 of NE1 and NE1 of Section 27, N2 of S2 of Section 28, E2 of NW1, W2 of NE1 and NE1 of NE1 of Section 29, N2 of NE1 of Section 30, T. 13 N., R. 5 W., M.D.M., and the NW1 of SW1 of Section 12, NE1 of NW1 of Section 15 and Lot 1 of Section 24, T. 13 N., R. 6 W., M.D.M., Lake County, California, containing a total of 709.37 acres.

SH. ACT. 20 YON BODDA JUZS

"The requested withdrawal is brought about by reason of a cooperative investigation under way between the Division of Water Resources and the County of Yolo, with the objective of presenting a plan or plans for the conservation and control of the waters of Cache Creek. The Division of Water Resources advises it is possible that a dam at the Wilson Valley Site, embracing the above parcels, may become an integral part of the plan of improvement to be proposed. Furthermore, we are advised that a report on the investigation will be made about June 30, 1957, at which time a definite determination will be made as to whether or not a dam is to be constructed in this area.

"These lands were acquired by the State from the Federal Government between 1921 and 1924, in lieu of second sections 16 and 36, and have been available for sale since that time.

"On September 6, 1955 an application to purchase the above-described lands in T. 13 N., R. 5 W., M.D.M., by Frances Cain, was filed, containing a total area of 109.37 acres. An appraisal of these lands was under way at the time of receipt of the aforesaid withdrawal request from the Division of Water Resources.

"Section 6210.2 of the Public Resources Code provides that 'The Commission may withdraw from sale any of the public lands belonging to the State and may restore any or all public lands so withdrawn, or other public lands, for sale.'"

UFON MOTION DULY MADE AND UNANIMOUSLY CARRIED, IT WAS RESOLVED AS FOLLOWS:
