1. (CONSIDERATION OF SUBSIDENCE COSTS - W. O. 2323.) The following report was presented to the Commission:

"In Opinion No. 56/145 of June 29, 1956, by the Attorney General, the State Lands Commission was authorized to give after-the-fact approval of expenditures between April 1, 1956 and July 5, 1956, made by the City of Long Beach, under the provisions of Section 1 (f) and of Section 5 (a) of Chapter 29 of the Statutes of 1956, First Extracidinary Session. By that same opinion the Attorney General indicated that prior approval would be required for such expenditures subsequent to the effective date of Chapter 29, i.e., July 5, 1956.

"Since the latter date, invoices have been presented to the City of Long Beach, by its contractors and others working on contracts involving subsidence cost expenditures, which will require approval by the State Landr Commission if credit is to be received by the City of Long Beach for such costs under the provisions of Section 5 (a) of Chapter 29.

"The staff of the State Lands Division has reviewed statements presented by the City of Long Beach with respect to such proposed expenditures after July 5, 1956. Final and complete approval as to the exact amount of work and costs involved cannot be had until after the work under each item has been completed and an engineering review and an audit have been made. The office of the Attorney General has advised, however, that the Commission may make a conditional prior approval and thus qualify the ultimate audited expenditures for credit under Section 5 (a)."

UPON MOTION LULY MADE AND UNANIMOUSING ARRIED, IT WAS RESOLVED AS FOLLOWS:

THE STATE LANDS COMMISSION APPROVES THE COSTS PROPOSED TO BE EXPENDED BY THE CITY OF LONG PEACH, INCLUDING SUBSIDENCE REMEDIAL WORK, AS SHOWN ON EXHIBIT "A" HERBOF; SUBJECT TO THE CONDITION, HOWEVER, THAT THE AMOUNT, LF ANY, OF EACH OF THE ITEMS TO BE ALLOWED ULTIMATELY AS SUBSIDENCE COSTS DEDUCTIBLE UNDER THE PROVISIONS OF SECTION 5 (a) OF CHAPTER 29, STATUTES OF 1956, FIRST EXTRAORDINARY SESSION, WILL HE DETERMINED BY THE COMMISSION UPON AN ENGINEERING THE AND PINAL AUDIT SUBSEQUENT TO THE TIME WHEN THE WORK UNDER ANY OF THESE THAN IS COMPLETED; THE EXECUTIVE OFFICER, OR THE ASSISTANT EXECUTIVE OFFICER, OR THE MINERAL RESOURCES ENGINEER AND AUTHORIZED TO EXECUTE APPROPRIATE WRITTEN INSTRUMENTS REFLECTING THE COMMISSION'S CONDITIONAL APPROVAL.
