1. UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, THE MINUTES OF THE MEETING OF AUGUST 15, 1956, WERE CONFIRMED AS WRITTEN AND MAILED TO MEMBERS OF THE COMMISSION.
