An application has been received from Mr. Edwin W. Pauley for authorization to conduct submarine geophysical exploration on those tide and submerged lands under the jurisdiction of the State Lands Commission lying between Coal Oil Point and Point Conception, Santa Barbara County. An operating permit has been requested for a 180-day period beginning December 1, 1956.
