(1957 LEGISLATION - W. O. 2115)

On August 15, 1956 (Minute Item 9, pages 2766-67, W. O. 2115.1) the Commission authorized the staff to have again introduced, with the concurrence of the Attorney General and of the Administrative Adviser of the Department of Finance, a bill amending Section 1007 of the Civil Code to provide that no title to State land may be acquired by prescription. In the process of development of language which would be satisfactory to all interested agencies, it was determined that the State Water Rights Board also has an interest in the problem. Mutually satisfactory language had not been completed at the end of the legislative bill introduction period. Therefore, it is suggested that staff work on this proposed bill be continued in order that legislation may be considered for introduction at the next session.

Also on August 15, 1956 (Minute Item 9, pages 2766-67, W. O. 2115.3) the Commission authorized the staff to have introduced a bill or bills, with the concurrence of the Attorney General and of the County Boards of Supervisors, that would coordinate County boundaries with the seaward State boundary as set forth in Sections 170 and 171 of the Government Code. The required concurrence of the Attorney General and of the County Boards of Supervisors had not been obtained by the end of the legislative bill introduction period and therefore it is suggested that the staff work on such concurrence be continued to permit consideration of introduction of the necessary legislation at the next session.

On September 27, 1956 (Minute Item 8, pages 2810-11, W.O. 2115.6) the Commission authorized the staff to have introduced a bill to correct an error in the description in the legislative grant of tide and submerged lands to the City of Sausalito under Chapter 534 of the Statutes of 1953. The necessity for correction of Chapter 534 of the Statutes of 1953 will be eliminated by repeal of this Act and an enactment of a revised grant Statute under Assembly Bill 323 introduced by Assemblyman McCollister.

The status of the balance of legislation considered by the Commission is given on the attached tabulation.
