1. UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, THE MINUTES OF THE MEETING OF THE STATE LANDS COMMISSION HELD IN SACRAMENTO, CALIFORNIA, ON DECEMBER 12, 1957, WERE APPROVED AS WRITTEN.
2. It was agreed informally that the next meeting of the Commission would be held prior to February 15, 1958, preferably during the week starting February 9, the specific date to be worked out by the Executive Officer on the basis of mutual convenience.
