UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, THE MINUTES OF THE MEETING OF THE STATE LANDS COMMISSION HELD IN SACRAMENTO ON OCTOBER 14, 1958, WERE APPROVED AS WRITTEN AND MAILED TO THE MEMBERS OF THE COMMISSION, SUBJECT TO CORRECTION OF THE WORK ORDER NUMBER ASSIGNED TO MINUTE ITEM 28 (PAGE 4324) FROM W.O. 2274.2 TO W.O. 3019.
