The United States Plywood Corporation has submitted for approval assignments of Lease P.R.C. 1677.1 from Mutual Plywood Corporation.

Lease P.R.C. 1677.1 was issued to Hanley Lumber Company on March 28, 1956 for fifteen years at an annual rental of \$100, with right of renewal for two consecutive periods of ten years each, for a log storage facility covering 8.95 acres of tide and submerged lands in the beds of Freshwater and Eureka Sloughs in the West half of Section 19, T. 5 N., R. 1 E., H.B.M. By assignment approved June 11, 1956, the lessee's interest was transferred to the present assignor. The land rental is paid to March 28, 1959, and the statutory filing fee has been received.

The performance bond will be continued by issuance of a new bond on behalf of the proposed assignee.
