

MINUTE ITEM

4. APPLICATION FOR APPROVAL OF LOCATION OF SUBMERGED TELEPHONE CABLE ACROSS TIDE AND SUBMERGED LANDS OF MONTEZUMA SLOUGH TO GRIZZLY ISLAND, THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY, SOLANO COUNTY - W.O. 3351, P.R.C. 2493.9.

After consideration of Calendar Item 9 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE AN APPROVAL OF LOCATION, IN THE FORM PREVIOUSLY APPROVED BY THE COMMISSION, TO THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY FOR A SUBMARINE CABLE CROSSING LANDS DESCRIBED AS FOLLOWS:

A STRIP OF LAND 50 FEET IN UNIFORM WIDTH, SITUATE IN MONTEZUMA SLOUGH APPROXIMATELY 1500 FEET EAST OF THE SOLANO COUNTY FERRY CROSSING TO GRIZZLY ISLAND, THE CENTERLINE OF SAID STRIP BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE MEAN HIGH TIDE LINE OF THE NORTH BANK OF MONTEZUMA SLOUGH WHICH BEARS S. 61° 53' 07" E., 1444.00 FEET; N. 82° 18' 40", 1644.64 FEET; AND S. 12° 37' W., 305 FEET, MORE OR LESS, FROM U. S. CORPS OF ENGINEERS BENCH MARK 149-6; THENCE FROM SAID POINT OF BEGINNING S. 12° 37' W., 771 FEET, MORE OR LESS, TO THE MEAN HIGH TIDE LINE ON THE SOUTH BANK OF MONTEZUMA SLOUGH.

APPLICATION FOR APPROVAL OF LOCATION OF SUBMERGED TELEPHONE CABLE ACROSS TIDE AND SUBMERGED LANDS OF MONTEZUMA SLOUGH TO GRIZZLY ISLAND, THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY, SOLANO COUNTY - W.O. 3351.

An application has been received from The Pacific Telephone and Telegraph Company, pursuant to Section 6502, Public Resources Code, for an approval of location for an easement across the tide and submerged lands of Montezuma Slough, approximately 1500 feet east of County Ferry Crossing, to Grizzly Island, Solano County, for a submarine telephone cable. No rental or performance bond is required. The expense deposit and statutory filing fee have been paid.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO EXECUTE AN APPROVAL OF LOCATION, IN THE FORM PREVIOUSLY APPROVED BY THE COMMISSION, TO THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY FOR A SUBMARINE CABLE CROSSING LANDS DESCRIBED AS FOLLOWS:

A STRIP OF LAND 50 FEET IN UNIFORM WIDTH, SITUATE IN MONTEZUMA SLOUGH APPROXIMATELY 1500 FEET EAST OF THE SOLANO COUNTY FERRY CROSSING TO GRIZZLY ISLAND, THE CENTERLINE OF SAID STRIP BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE MEAN HIGH TIDE LINE OF THE NORTH BANK OF MONTEZUMA SLOUGH WHICH BEARS S. 61° 53' 07" E., 1444.00 FEET; N. 82° 18' 40", 1644.64 FEET; AND S. 12° 37' W., 305 FEET, MORE OR LESS, FROM U. S. CORPS OF ENGINEERS BENCH MARK 149-6; THENCE FROM SAID POINT OF BEGINNING S. 12° 37' W., 771 FEET, MORE OR LESS, TO THE MEAN HIGH TIDE LINE ON THE SOUTH BANK OF MONTEZUMA SLOUGH.
