

MINUTE ITEM

8. QUITCLAIM OF MINERAL PROSPECTING PERMIT P.R.C. 2217.2, LOUIS RALPH MORRIS, SANTA BARBARA COUNTY - W.O. 2962.

After consideration of Calendar Item 5 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ACCEPT THE QUITCLAIM AND TO ALLOW THE TERMINATION OF PROSPECTING PERMIT P.R.C. 2217.2 COVERING 40 ACRES OF LAND, IN WHICH THE MINERALS HAVE BEEN RESERVED TO THE STATE, IN THE SE $\frac{1}{4}$ OF THE SW $\frac{1}{4}$ OF SECTION 21, T. 11 N., R. 31 W., S.B.B.& M., SANTA BARBARA COUNTY, THE QUITCLAIM TO BE EFFECTIVE NOVEMBER 10, 1959, AS REQUESTED BY THE PERMITTEE, LOUIS RALPH MORRIS.

QUITCLAIM OF MINERAL PROSPECTING PERMIT P.R.C. 2217.2, LOUIS RALPH MORRIS, SANTA BARBARA COUNTY - W.O. 2962.

Prospecting Permit P.R.C. 2217.2, covering 40 acres of land in which minerals have been reserved to the State in the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 21, T. 11 N., R. 31 W., S.B.B. & M., Santa Barbara County, was issued to Louis Ralph Morris, the surface owner, on November 13, 1958, pursuant to Section 6891 of the Public Resources Code, for a period of two years, to prospect for minerals other than oil and gas.

No operations have been conducted on the subject land, and the permittee wishes to quitclaim the permit, this request being based on the result of operations conducted on adjacent lands by other interests. These operations, as reported, consisted of ore crushing and concentration, and yielded gold in insufficient quantities to be considered profitable.

The permittee has submitted a quitclaim to his rights under the permit, dated November 10, 1959.
