THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT FOR A PERIOD NOT TO EXCEED 25 YEARS TO THE DEPARTMENT OF FISH AND GAME FOR A PARCEL OF TIDE AND SUBMERGED LAND OF THE KLAMATH RIVER FOR THE CONSTRUCTION, USE AND MAINTENANCE OF A BOAT-LAUNCHING RAMP. THE CONSIDERATION FOR THE ISSUANCE OF THE PERMIT IS THE PUBLIC USE AND BENEFIT. THE PARCEL IS DESCRIBED AS FOLLOWS:

A 50-FOOT STRIP OF TIDELANDS BEING 25 FEET ON EITHER SIDE OF A CENTERLINE FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK OF THE RIGHT BANK OF THE KLAMATH RIVER THAT BEARS S. 0° 18' W., 45.4 FEET AND S. 59° 48' E., 53.8 FEET FROM THE NW CORNER OF LOT 4, SECTION 19, T. 13 N., R. 2 E., H.M., THENCE S. 36° 52' W., 40.0 FEET, CONTAINING 0.046 ACRE, MORE OR LESS.

APPLICATION FOR A PERMIT TO CONSTRUCT A BOAT LAUNCHING RAMP ON THE RIGHT BANK OF KLAMATH RIVER AT KLAMATH GLEN, DEL NORTE COUNTY, DEPARTMENT OF FISH AND GAME - V.O. 3454.

An application has been received from the Department of Fish and Game, pursuant to Section 6502 of the Public Resources Code for a 25-year easement over a parcel of tide and submerged land of the Klamath River 50 feet in width riverward and 40 feet in length, containing 0.046 acre, more or less, to be used for the construction, maintenance and use of a boat launching ramp. The adjoining upland tract is leased to the Department of Fish and Game for 25 years. No bond, filing fee, or rental is required.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A PERMIT FOR A PERIOD NOT TO EXCEED 25 YEARS TO THE DEPARTMENT OF FISH AND GAME FOR A PARCEL OF TIDE AND SUBMERGED LAND OF THE KLAMATH RIVER FOR THE CONSTRUCTION, USE AND MAINTENANCE OF A BOAT LAUNCHING RAMP, THE CONSIDERATION FOR THE ISSUANCE OF THE PERMIT TO BE THE PUBLIC USE AND BENEFIT.
