An application has been received from Union Oil Company of California for approval of plans to remove the wooden portion of a pier and to replace it with a concrete pier structure. The pier is located upon tide and submerged lands of San Pablo Bay at Oleum, near Rodeo, Contra Costa County, which site is covered by Lease P.R.C. 600.1, issued to the applicant on April 6, 1951, for a period of 15 years. A staff inspection of the premises resulted in an estimate that the replacement is 75% complete.

The applicant has also requested a reduction in the amount of the surety bond of \$80,000 now in force, because of the replacement of all wooden parts of the structure with concrete and steel members. It is the recommendation of the staff that upon determination that the replacement work has been completed, a reduction of the bond be made to \$25,000. No filing fee is required.
