An application has been received from the County of Mono for a use permit covering a strip of submerged lands 200 feet in width, approximately paralleling the low water mark of Mono Lake in Government Lot 3, Section 5, T. l N., R. 26 E., M.D.B.& M., Mono County, for use as a boat-launching facility.
