MINUTE ITEM

17. APPLICATION FOR GAS LINE RIGHT-OF-WAY EASEMENT CROSSING SUBMERGED LANDS OF SACRAMENTO RIVER IN TEHAMA COUNTY, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 3525, P.R.C. 2573.1.

After consideration of Calendar Item 12 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE PACIFIC GAS AND ELECTRIC COMPANY A RIGHT-OF-WAY EASEMENT FOR 49 YEARS FOR GAS PIPE LINES CROSSING UNDER THE FOLLOWING-DESCRIBED PARCEL OF SUBMERGED LANDS OF THE SACRAMENTO RIVER, SITUATE IN TEHAMA COUNTY:

A STRIP OF LAND 100 FEET WIDE EXTENDING ACROSS THE SACRAMENTO RIVER, LYING 50 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT U.S.B.R. STRTION TC 3-1952 ZONE 1 (COORDINATES X = 1,948,771.48 AND Y = 293,459.58) RUNNING THENCE N. 29° 06' E. 4,340.36 FEET TO A POINT ON THE SOUTH LEVEE OF THE SACRAMENTO RIVER; THENCE N. 11° 43' E. 70 FEET TO A POINT ON THE LOW WATER LINE ON THE RIGHT BANK OF THE SACRAMENTO RIVER, WHICH POINT IS THE 1.JE POINT OF BEGINNING OF THE ABOVE-MENTIONED CENTERLINE; THENCE CONTINUING N. 11° 43' E. 1,170 FEET, MORE OR LESS, TO A POINT ON THE LOW WATER LINE ON THE NORTH BANK OF THE SACRAMENTO RIVER, CONTAINING 2.685 ACRES, MORE OR LESS.

THE TOTAL RENTAL FOR THE 49-YEAR TERM IS \$1,248.03, PAYABLE IN ADVANCE, WITH NO BOND REQUIRED.

APPLICATION FOR GAS LINE RIGHT-OF-WAY EASEMENT CROSSING SUBMERGED LANDS OF SACRAMENTO RIVER IN TEHAMA COUNTY, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 3525.

An application has been received from Pacific Gas and Electric Company for lease of a right-of-way 100 feet in width and 1,170 feet in length, containing 2.686 acres, more or less, for gas pipe lines under the Sacramento River $3\frac{1}{2}$ miles southeast of Red Bluff in Tehama County.

The estimated value of the lands to be crossed is \$100 per acre; therefore, the calculated rental for a 49-year term would be \$1,248.03, payable in advance.

No performance bond is required. The statutory filing fee and expense deposit have been paid.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE PACIFIC GAS AND ELECTRIC COMPANY A RIGHT-OF-WAY EASEMENT FOR 49 YEARS FOR GAS PIPE LINES CROSSING UNDER THE FOLLOWING-DESCRIBED PARCEL OF SUBMERGED LANDS OF THE SACRAMENTO RIVER, SITUATE IN TEHAMA COUNTY:
