19. APPLICATION FOR AMENDMENT OF LEASE P.R.C. 2148.1, SUBMERGED LANDS OF SAN FRANCISCO BAY OFF EASTERLY SHORE OF BELVEDERE PENINSULA IN MARIN COUNTY, PULLMAN BUILDING CO. - W.O. 3501.

After consideration of Calendar Item 22 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO APPROVE, EFFECTIVE APRIL 7, 1960, AN AMENDMENT TO LEASE P.R.C. 2148.1, ISSUED TO PULLMAN BUILDING CO., TO PROVIDE FOR THE ENLARGEMENT FROM 2.44 ACRES TO 5.358 ACRES, THE RENTAL TO BE INCREASED FROM \$100 TO \$486.34 ANNUALLY, WITH NO CHANGE IM BOND REQUIREMENTS.

APPLICATION FOR AMENDMENT OF LEASE P.R.C. 2148.1, SUBMERGED LANDS OF SAN FRANCISCO BAY OFF EASTERLY SHORE OF BELVEDERE PENINSULA IN MARIN COUNTY, PULLMAN BUILDING CO. - W.O. 3501.

An application has been received from Pullman Building Co. for enlargement of their present State leasehold from 2.44 acres to 5.358 acres to provide the required space for a bost harbor.

Lease P.R.C. 2148.1, covering 2.44 acres of time and submerged lands off Paradise Cove two miles south of San Quencia Point, was issued on April 7, 1958, for a term of 15 years, with provision for three 10-year renewal periods.

The lands proposed to be included are estimated to have a value of \$2,000 per acre; therefore, the annual reptal would be increased from \$100 to \$486.34. The present performance bond of \$2,000 is considered sufficient. No filing fee is required. The expense deposit has been received.

IT IS RECOMMENDED THAT THE EXECULTURE OFFICER BE AUTHORIZED TO APPROVE, EFFECTIVE APRIL 7, 1960, AN AMENDMENT TO LEASE P.R.C. 2148.1, ISSUED TO PULLMAN BUILDING CO., TO PROVIDE FOR THE ENLARGEMENT FROM 2.44 ACRES TO 5.358 ACRES, THE BENTAL 7 BE INCREASED FROM \$100 TO \$486.34 ANNUALLY, WITH NO CHANGE IN BOND REQUIREMENTS.
