29. APPLICATION FOR MINERAL EXTRACTION LEASE, MONTEREY BAY, MONTEREY COUNTY, GRANITE CONSTRUCTION COMPANY - W.O. 3471.

After consideration of Calendar Item 20 attached and upon motion duly made and unanimously carried, the following reso: 'on was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO OFFER FOR LEASE, PURSUANT TO COMPETITIVE PUBLIC BIDDING, FOR THE EXTRACTION OF SAND AT A MINIMUM ROYALTY OF SIX CENTS PER CUBIC YARD FOR ALL SAND EXTRACTED, THE FOLLOWING AREA OF TIDE AND SUBMERGED LANDS, MONTEREY BAY, MONTEREY COUNTY:

A PARCEL OF TIDE AND SUBMERGED LANDS LYING BETWEEN THE LINE OF ORDINARY HIGH WATER MARK OF MONTEREY BAY AND THE LINE DRAWN PARALLEL THEREWITH AND 200 FEET SEAWARD THEREFROM AND BETWEEN THE SOUTHWESTERLY BOUNDARY OF THAT CERTAIN 41.01-ACRE PARCEL OF LAND DESCRIBED IN LEASE FROM JNO. L. D. ROBERTS TO PACIFIC AGGREGATES, INC., DATED OCTOBER 18, 1946, PROJECTED NORTHWESTERLY AND A LINE DRAWN PERPENDICULAR TO THE SHORE LINE OF MONTEREY BAY AND RUNNING NORTHWESTERLY FROM THE POINT OF INTERSECTION OF THE LINE OF ORDINARY HIGH WATER MARK OF MONTEREY BAY WITH THE NORTHERLY LINE OF LOT 1 OF THE RANCHO NOCHE BUENA PROJECTED WESTERLY, CONTAINING APPROXIMATELY EIGHT ACRES.

APPLICATION FOR MINERAL EXTRACTION LEASE, MONTEREY BAY, MONTEREY COUNTY, GRANITE CONSTRUCTION COMPANY - W.O. 3471.

An application has been received from the Granite Construction Company, a California corporation, requesting that an area of approximately eight acres of tide and submerged lands in the vicinity of Seaside Beach, Monterey Bay, Monterey County, be offered for lease for sand extraction pursuant to competitive public bidding in accordance with the provisions of Division 6 of the Public Resources Code. Sandfrom this general area is used as an aggregate and is also processed for use in sandblasting. The applicant is the upland owner of the area shoreward of the proposed operations.

The statutory filing fee has been paid and the required expense deposit has been made.

The application has been referred to the Department of Natural Resources and the office of the Attorney General, as required under Section 6818 of the Public Resources Code which states in part: "All applications made to the State Lands Commission . . . for erection of any permanent structure on tidelands or submerged lands or for . . . removal therefrom of any material shall be submitted by the commission to the Director of Natural Resources to make an examination and report concerning possible interference with the recreational use of lands littoral to the tidelands or submerged lands involved in such application. All such applications shall also be submitted by the commission to the Attorney General for approval as to compliance with the applicable provisions of law and of the rules and regulations of the commission." The Department of Natural Resources has reported that an examination of this application indicates no possible interference with the recreational use of lands littoral to the tidelands and submerged lands involved in the application. The office of the Attorney General has advised that the application complies with applicable laws and the rules and regulations of the Commission.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO OFFER FOR LEASE, PURSUANT TO COMPETITIVE PUBLIC BIDDING, FOR THE EXTRACTION OF SAND AT A MINIMUM ROYALTY OF SIX CENTS PER CUBIC YARD FOR ALL SAND EXTRACTED, THE FOLLOWING AREA OF TIDE AND SUBMERGED LANDS, MONTEREY BAY, MONTEREY COUNTY:

A PARCEL OF TIDE AND SUBMERGED LANDS LYING BETWEEN THE LINE OF ORDINARY HIGH WATER MARK OF MONTEREY BAY AND THE LINE DRAWN PARALLEL THEREWITH AND 200 FEET SEAWARD THEREFROM AND BETWEEN THE SOUTHWESTERLY BOUNDARY OF THAT CERTAIN 41.01-ACRE PARCEL OF LAND DESCRIBED IN LEASE FROM JNO. L. D. ROBERTS TO PACIFIC AGGREGATES, INC., DATED OCTOBER 18, 1946, PROJECTED NORTHWESTERLY AND A LINE DRAWN PERFENDICULAR TO THE SHORE LINE OF MONTEREY BAY AND RUNNING NORTHWESTERLY FROM THE POINT OF INTERSECTION OF THE LINE OF ORDINARY HIGH WATER MARK OF MONTEREY BAY WITH THE NORTHERLY LINE OF LOT 1 OF THE RANCHO NOCHE BUENA PROJECTED WESTERLY, CONTAINING APPROXIMATELY EIGHT ACRES.
