

MINUTE ITEM

15. IMPERIAL IRRIGATION DISTRICT, EL CENTRO, IMPERIAL COUNTY, S.W.O. 7656 - APPLICATION TO PURCHASE, ANTHONY AND LAURA FRIGOLETTO, NO. 11635, S.W.O. 7696.

After consideration of Calendar Item 23 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION REJECTS THE APPLICATION OF ANTHONY AND LAURA FRIGOLETTO (NO. 11635, S.W.O. 7696) TO PURCHASE THE NE $\frac{1}{4}$ OF THE NW $\frac{1}{4}$ OF SECTION 16, T. 8 S., R. 10 E., S.B.M., CONTAINING 40 ACRES IN RIVERSIDE COUNTY, AND DIRECTS THE REFUND OF ALL DEPOSITS TO SAID APPLICANTS.

The Commission, by resolution adopted at the meeting of May 24, 1960, authorized the sale, among other lands, of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 16, T. 8 S., R. 10 E., S.B.M., to the Imperial Irrigation District at the market value to be established by staff appraisal following the filing of a standard purchase application, without advertising for competitive bids. This action was undertaken as a result of the desire of the Imperial Irrigation District to acquire title to lands under the jurisdiction of the State Lands Commission which underliethe waters of Salton Sea in Imperial and Riverside counties.

An application was received on May 20, 1960 from Anthony and Laura Frigoletto of Woodside, New York, to purchase the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 16, T. 8 S., R. 10 E., S.B.M. (No. 11635, S.W.O. 7696), at \$3 per acre, pending appraisal. This parcel is one of those reserved by Commission action for sale to the Imperial Irrigation District.

In view of the foregoing, it appears in order that the Commission reject the application of Anthony and Laura Frigoletto.
